
Dairy Program Overview

- Since July 1, 1987, Sonoma County Department of Health Services, Environmental Health has served as the local Approved Milk Inspection Service (AMIS) for both Sonoma and Marin.
- AMIS authority is delegated by California Department of Food and Agriculture (CDFA) according to California Food and Agriculture Code, **Section 33171.**
- Six counties are approved by CDFA to run local dairy inspection programs.

- Imperial O Tulare/Kings
- San Joaquin
- Sonoma/Marin



Local Program Sustainability



Program Challenges

- Decreased programmatic revenue with increasing operational costs
- Decreased workloads necessitate a reduction of current staffing levels
- Decreased local staffing would limit program availability to farms
- Potential decline in local service response times



Fee Study Analysis

- 2024 Wohlford Consulting comprehensive analysis of user fees
 - Staff time and associated expenses determine full cost of fee
 - > Full cost recovery would require \$399.18/month
 - ➤ Identified underutilization of .50 FTE staff
 - Current county dairy inspection fee is \$217.00 a month
 - CDFA maximum allowable limit for dairy is \$257/month
 - Requirement to remit 15% of program revenue to CDFA
 - ➤ Board subsidy is currently \$126,495
- Without adjustments to staffing or fees for FY 2024-2025, the dairy program is projected to face a funding shortfall of \$339,515, equivalent to 62% of the anticipated program costs.

FY 2024-2025 Dairy Program Options

- 1. Return Program to CDFA on January 1, 2025
- 2. Continue Local Program with Fee Increase
- 3. Maintain Local Program with No Fee Increase



Option 1: Return Program to CDFA

- Transfer responsibilities to CDFA, effective January 1, 2025
- Six month of DHS operation in FY 24-25
- Local fee to remain flat at \$217/month for six months
- \$65,479 less in Sonoma and Marin Board subsidy from FY 2023-2024
- Delete 2 Dairy Inspector positions
 - .5 FTE Dairy Inspector Currently Vacant
 - 1.0 FTE Dairy Inspector Layoff Required
 - Vacant positions within EHS available

Option 2: Continue Local Program with Fee Increase

- Sustain local delivery of program through DHS
- Fee Increase to match State program
 - Increase monthly fee from \$217 to \$257 (\$40); Annual increase per farm from \$2,604 to \$3,084 (\$480)
- Funding gap of \$188,189, increased subsidy of \$11,096 from FY 2023-2024
- Delete 1 Dairy Inspector position
 - ➤ .5 FTE Dairy Inspector Currently Vacant
- Program Sustainability Challenges
 - ➤ Risks of future dairy closures
 - Reduced workloads for remaining FTE
 - Increasing demand for subsidy
 - Lack of inspector back up

Option 3: Maintain Local Program with No Fee Increase

- Maintain Local Program with no fee increases
- Funding gap of \$223,229, increase in subsidy of \$46,136 from FY 2023-2024
- Delete 1 Dairy Inspector position
 - .5 FTE Dairy Inspector Currently Vacant
- Program Sustainability Challenges
 - > Risks of future dairy closures
 - Reduced workloads
 - Increasing demand for subsidy
 - Risks of inspector coverage and back up
