**PROJECTS** 

Sonoma County Water Agency (Sonoma Water) and its affiliated sanitation districts require wastewater collection, treatment, storage, and disposal master planning services and special studies.

Wastewater treatment plant master plans provide an overall plan to coordinate and prioritize recommended improvements that incorporate past studies, completed improvements, and future improvements to maintain system reliability, address current and potential regulatory requirements, and enhance plant performance to reduce operational costs and incorporate process enhancements.

On October 20, 2021, Sonoma County Water Agency and its affiliated sanitation districts (collectively "Sonoma Water") issued a Request for Statements of Qualifications (RFQ) to the following 21 firms:
