### **Current Program Overview**

- Approved Activities
  - Evacuating/Feeding/Watering or care for livestock
  - Irrigating Crops
  - Fueling Emergency Generators
  - Auxiliary support to emergency personnel
- 168 Applications received
  - 103 have been issued
    - 46 have been issued for Commercial Livestock Producers
    - 43 have been issued for Commercial Plant Agriculture Producers
    - 14 was issued for both Livestock and Plant Agriculture Producers

  - Appointment with the Sheriff's Office

## **UCCE Survey Results**

- Fire Safety Training Course
- 71 completed a survey related to obtaining an Ag Pass
- 66 respondents are eligible to apply for an Ag Pass
- 33 respondents obtained an Ag Pass

### Of those:

- All were owner/operators or full-time employees
- The majority (20) were winegrape growers
