Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, authorizing budgetary adjustments to the 2024-2025 Final Budget for the Sheriff's Office in the amount of \$1,450,357.

**Whereas,** during FY 24-25 Budget Hearings, the Board approved a one-year pilot program for a Sheriff's Narcotic's program under the conditions of certain financial circumstances, and

Whereas, the conditions of the financial circumstances have been met and the Sheriff has been authorized to proceed with the establishment of a Narcotic's Unit pilot program for one year, and

**Whereas,** the Sheriff's Office requires budgetary appropriations be transferred between Divisions to implement the Narcotic's Unit Pilot program, and

Whereas, the Board of Supervisors has adopted a Final Budget for the Sheriff's Office, and

Whereas, the Government Code allows for adjustments to the Final Budget during the FY 2024-2025 Fiscal Year.
