## Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, Ratifying The Proclamation Of Local Emergency For The County Of Sonoma Operational Area Due To The Point Fire

Whereas, on June 17, 2024, the Director of Emergency Services for the County of Sonoma Issued a Proclamation of a Local Emergency for the County of Sonoma, State of California, due to conditions of extreme peril to the safety of persons and property that have arisen within the County as of June 16, 2024, caused by the Point Fire (the "Director's Proclamation of Local Emergency"); and

Whereas, pursuant to Sonoma County Code Chapter 10, Article 1, Section 10-5, where the Director of Emergency Services proclaims a local emergency, the Board of Supervisors must ratify said declaration within seven (7) days after such proclamation; and,

Whereas, the conditions of extreme peril caused by the Point Fire have significantly impacted County and community operations and resources, and require the provision of additional public safety, health and emergency services; and

Whereas, resources regionwide are significantly strained due to the recent red flag event in the region and around the state; and

Whereas, the conditions of extreme peril to the safety of persons and property will

continue within the County because of the ongoing damages caused by the Point Fire, and the situation is of such severity and magnitude that effective response is beyond the capabilities of the affected local governments; and

Whereas, the Board of Supervisors does hereby find that the circumstances of the Point

Fire and the impacts as described in the Director's Declaration of Local Emergency do constitute

a risk of extreme peril and support and justify the declaration of local emergency set forth

therein, the request for the Governor of the State of California to proclaim a State of

Emergency; and the request to make additional assistance available, including but not limited

to California Disaster Act Assistance; and

**Now, Therefore, Be It Resolved** the Board of Supervisors does hereby ratify the Director's Declaration of Local Emergency, effective immediately upon the adoption of this resolution.

Be It Further Resolved and Proclaimed that the County Administrator/Executive is delegated authority to take all actions reasonably necessary to respond to the Point Fire, including but not limited to providing appropriate direction and authority to Human Resources and the County Payroll Manager regarding employee pay for time not worked and for straight overtime as provided in the Salary Resolution due to impacts from the emergency resulting from the incident for pay periods in which this pay is reasonable and necessary.
