Projected Change in Net Revenue

Animal Services	\$13,031
Environmental Health	(\$76,970)
Public Health Laboratory	\$36,720
Driving Under the Influence (DUI) Program	\$621,670

Sonoma County Animal Services

- Proposed fee increases between 2% to 43% to match full cost recovery
- New fees:
 - Private Pet Cremations
- Estimated Revenue: \$639,515, an increase of \$13,031
- Ongoing General Fund SCAS subsidy of \$287,901, and use of DHS General Fund allocation to cover estimated gap of \$863,499.
- Designed to balance affordability and full cost recovery while considering market comparability

Environmental Health

- Proposed Fee Changes:
 - Utilization of the fee stabilization fund to minimize cost impact
 - Utilizing ongoing General Fund subsidy of \$34,682
 - No fee increase recommended for FY 2025-2026
- Estimated Revenue: \$7,686,487 a decrease of \$76,970
- New Fees:
 - Microenterprise Home Kitchen Operation
 - Solid Waste Non-Operational Site
- Department will monitor MEHKO fiscal impacts

Public Health Laboratory

- Proposed Fee Changes:
 - Approximately 8% increase across most fees to recover increased labor and supply costs
 - Fees set below full-cost recovery, subsidized by grants and health realignment funding
- New Fees:
 - Tests for specialized services like MALDI-TOF, tick identification, and wastewater surveillance
 - Clinical Molecular Laboratory fee increase of 31% for SARS-CoV-2/Flu/RSV
- Estimated Revenue: \$345,894 an increase of \$36,720

DUI Program

- Proposed Fee Changes:
 - 35% increase for all programs, including First Offender and Multiple Offender Programs
- Estimated Revenue: \$2,753,111 an increase of \$621,670
- Cost Recovery Analysis:
 - CA Code Title 9 mandates DUI programs must be self-sustaining and fully funded by participant fees
 - Increase offsets a structural deficit currently covered by existing DHS General Fund allocation
 - Fee increases based on a detailed cost study and local program
 - Total program costs estimated at \$3,914,470, with the \$1,161,359 gap subsidized by Department funds
