**Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,
Adopting New And Amended Fees Effective July 1, 2026 To Recover The Reasonable Cost Of
Providing Environmental Health And Safety Services**

Whereas, the Board of Supervisors is authorized to establish fees to recover the reasonable cost of providing certain health services pursuant to Health and Safety Code Section 101325;

Now, Therefore, Be It Resolved that to recover the reasonable cost of providing certain health services, it is necessary to establish certain new fees as set forth below;

Be It Further Resolved, that to recover based on information presented to this Board, this Board finds that the proposed fees comply with all legal requirements, including Art. XIII C of the California Constitution.

Be It Further Resolved that in all other respects, Resolution No. 25-0331, dated July 8, 2025, setting fees effective July 8, 2025, and any fee modifications established by subsequent resolution, shall remain in full force and effect.

Be It Further Resolved that if any section, subsection, sentence, clause or phrase of this resolution is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portion of this resolution.

Be It Further Resolved that the following new fees for health services are hereby adopted effective July 1, 2026.
