

1.1 CONSTRUCTION PATH OF TRAVEL AND LAY-DOWN AREA

1.2 BIDDERS QUESTIONS AND ANSWERS FROM COUNTY

1. Who is the existing DDC Controls supplier?

County Response: The existing controls are Andover Controls Infinity System.

2. Will Specs be provided for this project?

County Response: Yes, specifications are provided for this project.

3. Have there been any approved alternates for the mechanical equipment?

County Response: To date there have been no approved alternates for the mechanical system.

4. Will alternate equipment be accepted?

County Response: Alternates will be reviewed on an individual basis for adequacy as they relate to multizone VRF equipment originally specified with R410A which is now entering the phase-out period noted on sheet M0.01.

5. What are the working hours?

County Response: Working hours are from 8AM to 5PM with a preference for noisy/disruptive work to be performed after-hours between 8PM and 7AM.

6. Can you provide a duct construction schedule?

County Response: Ductwork shall be in accordance with Specification 23 31 13 – Metal Ducts, and SMACNA Duct Construction Standards – Metal and Flexible, 4th Edition.

7. What insulation is required for the ductwork?

County Response: Insulation is required per Specification 23 07 00 and shall be R-8 Minimum per 2022 California Energy Code, Section 120.4(a).

8. Will duct cleaning be required?

County Response: Duct cleaning of new systems shall not be required. Newly constructed systems shall be left in ready and clean condition.

9. Is hard refrigerant piping required?

County Response: Yes, refrigerant piping shall be hard piped and shall meet the requirements listed within Specification 23 23 00


