Approach

- Developed an equity screening tool to guide project implementation and align with the Office of Equity's vision, mission, and values
- Organized a County Advisory Group and an Expert Advisory Group to develop the research approach, review preliminary findings, and inform recommendations
- Methods included a literature review, 6 key informant interviews, 25 food distribution provider interviews, and 5 focus group interviews with people experiencing food insecurity and frontline workers

Literature Review

Guiding questions:

- What do we know about current levels of food insecurity in Sonoma County?
- What are noteworthy trends?
- What demographics are most impacted (who, where, and why)?
- What external events influence food distribution trends?
- Literature review led us to a focus on certain groups

Themes From People Experiencing Food Insecurity



- High cost of living is a significant contributor to food insecurity in Sonoma County
- Aspects of the government safety net could improve
- Food distribution locations are not always accessible
- Food choices can continue to improve

Themes From Food Providers

- Pandemic affected funding and operations
- Challenges to providing convenient, accessible food distribution
- Challenges providing diverse food choices, enough food, healthy food, and prepared food
- Inconsistent, reduced funding leads to waitlists and program uncertainty
- More expert staff is needed, including case managers and dietitians
- Rural and remote communities and neighborhoods of Sonoma County have transportation challenges and feel overlooked
- Information is needed to improve programs

Participant Ideas for Improvements

- Greater leadership and coordination from the County
- Dedicated County staff to support the food system
- More flexible and reliable funding
- Better sharing of resources and addressing higher-level issues
- Providing land and other resources for growing and storing food
- Address challenges unique to each Supervisorial District

Recommendations and Strategies

Each broad recommendation includes strategies and specific activities that the county and the community based organizations can take:

Recommendations for the County



- County should recognize and elevate its role as a collaborative leader in addressing food and nutrition security
- County should use the strong community support to lead food and nutrition security responses

Strategies for the County

- 1. Create a staffing structure to allow the County to become a more effective partner in fostering community food and nutrition security
- 2. Convene a regular forum and more frequent working groups to share information and best practices, build relationships, and learn across sectors
- 3. Integrate the food assessment recommendations into the County Strategic Plan and the County General Plan

Strategies for the County

- 4. Find new ways to collect and share information and enable datadriven decision-making
- 5. Increase effectiveness in administering government safety-net food programs
- 6. Increase the capacity of community-based organizations through direct funding and supporting organizational resiliency



Recommendations for Community Based Organizations

- 1. Continue to look for opportunities to colocate food distribution services with other services
- 2. Continue to focus on providing choice and making food accessible by making it culturally relevant and convenient
- 3. Add share tables at food distribution sites so people can take or leave items
- 4. Offer to distribute food before or after work hours
- 5. Clarify and align nutrition and food distribution goals
- 6. Train volunteers to support cultural competency when distributing food
- 7. Work to ensure that school meals can be staffed during breaks
- 8. Research if/how canned food is used or distributed
