**SUBJECT:** **Selection of Gaya Coating Consulting Inc. for Inspection Services for Ralphine Tank No. 1 Recoating Project**

Water storage tanks are an integral component of the water transmission system that require periodic recoating and painting to maintain the original lifespan of the structure, prevent corrosion and subsequent infrastructure replacement costs, and ensure water storage and transmission reliability.

Sonoma Water's Capital Improvement Plan identifies key infrastructure projects to meet the needs of wastewater, flood management, and water transmission facilities within its jurisdiction and includes a tank recoating program.

Under this Agreement, Gaya Coating Consulting Inc. (Consultant) will coordinate and schedule on-site inspections, provide testing equipment and perform compliance tests, prepare and submit daily inspection reports during construction, and take digital photographs of significant features and damaged or defective areas for the Ralphine Tank No. 1 Recoating Project.

Gaya Coating Consulting Inc. (Consultant) was selected from a list of qualified consultants developed from a competitive selection process. Attached is a memo that explains the competitive selection process.

Consultant was selected for the subject work because of Consultant's outstanding level of qualifications and experience. Consultant specializes in tank coating processes and materials, is registered with professional standards associations, and has over 25 years of experience working with many municipalities around the Bay Area.

Internal bargaining unit staff is not being used for this work because work is beyond the capacity of staff.

The hiring of Consultant for this agreement causes no conflict of interest and is not based on any financial incentive provided to Sonoma Water or its employees and representatives.
