## **ITEM #3A ADDED BY ADDENDUM**

 3A. The Board of Supervisors, the Board of Directors of the Sonoma County Water Agency, the Board of Directors of the Community Development Commission, and the Board of Directors of the Sonoma County Agricultural Preservation and Open Space District will consider the following in closed session: Conference with Legal Counsel - Existing Litigation - COUNTY OF SONOMA, et al. v. PACIFIC GAS AND ELECTRIC, et.al. Sonoma County Superior Court Case No. SCV 267391 (Government Code Section 54956.9(d) (1).)

The Board approved the settlement of the claim against Pacific, Gas & Electric Company brought by the following Sonoma County entities: County of Sonoma, the Sonoma County Water Agency, Sonoma County Community Development Commission, and the Sonoma County Agricultural Preservation and Open Space District. The settlement is a global settlement between these 4 Sonoma County entities, the City of Santa Rosa, the Town of Windsor, the City of Healdsburg, and the City of Cloverdale (collectively, the "Public Entities") and Pacific Gas & Electric Company for payment of \$31 million dollars from PG&E to the Public Entities in exchange for a full release of all claims related to the 2019 Kincade Fire. Direction was given to the Chair of the Board of Supervisors and Board of Directors and County Counsel to execute all documents necessary to effectuate the settlement.
