    - \$ 9.3 million County funding, including Measure M
    - \$ 16.1 million grant funding
    - \$ 9.6 million partner and donor funding
    - \$ 1.9 million park mitigation fees
    - \$ 150,000 impact mitigation and developer funds
    - \$ 6.2 million in funds allocated in prior fiscal years
- FY 2025-26 <u>Annual</u> Budget \$43.3 million in Total Expenditures
  - One new capital project is proposed.

# Update on the Capital Improvement Plan

- Annual Allocation allows for patches and repairs, not sufficient for large improvements or projects.
  - \$5.5 million annual allocation
    - \$1.6 million for ADA
    - \$180,000 for Sheriff's Telecommunication Towers
    - \$367,000 for MADF Connector Loan Repayment
    - Leaving \$3,353,000 for general capital improvements and repairs
- In 2025-26 \$113 million of funding requests were submitted
  - Including \$107 million from the Sheriff's Office
- Upcoming changes to 5-year Capital Improvement Plan
  - Make it a "Plan" by
    - Including only projects that have funding
    - Comply with AB602 Include information on est. completion date, funding sources, total funding allocated, and % of project funded

# SPI – 25-26 General Government CIP Preliminary Budget Overview

  - 51 general government projects totaling \$178.8 million
- \$5.5 million annual General Fund Allocation
  - \$1.967 million for American Disability Act (ADA) Projects (Including \$367k from general capital project allocation for final repayment for MADF Construction Loan)
  - \$3.42 million for general government projects
  - \$180K passed to Sheriffs for Telecommunication Towers
- \$476,098 from Measure L for Memorial Buildings
- \$405,160 from the Tobacco Secured fund and \$95,000 from the Criminal Justice Construction Fund for Generator Enhancements at the Juvenile Justice Center
