Whereas, the Human Services Department is requesting authorization to add 1.0 full time equivalent Program Development Manager to the Administrative Services Division – South County Center effective August 4, 2020. The position will be the on-site manager at the South County location overseeing day-to day operations, approximately 50 staff, and providing outreach and collaboration with various county and community partners, and

Whereas, the Human Services Department is requesting authorization to add 2.0 full time equivalent Children's Residential Care Counselors to the Family, Youth and Children's Division effective August 4, 2020. These positions will reduce the need for overtime and extra help while allowing the facility to maintain licensing requirements related to adult to child ratios, and

Whereas, the Human Services Department is requesting authorization to add 1.0 time-limited full time equivalent Public Assistance Systems Specialist to the Administrative Services Division – Information Technology effective August 4, 2020 to support the implementation of the new statewide automated eligibility program, CalSAWS, which is set to be completed by June 30, 2024, and

Whereas, the Human Services Department is requesting authorization to add 1.0 time-limited full time equivalent Program Planning and Evaluation Analyst to the Adult and Aging

The position will administer the Mental Health Services Act (MHSA) Innovations funding for the Collaborative Care Enhanced Recovery Project, CalFresh Healthy Living (SNAP-Ed) and the Dignity at Home Falls Prevention Program (DAHFPP) programs through June 30, 2022, and

Whereas, the Human Services Department is requesting authorization to add 1.0 time-limited full time equivalent Public Assistance Systems Technician to the Family, Youth and Children's Division effective August 4, 2020. This position will support the implementation of deliverable software to support the Child Welfare Services-California Automated Response and Engagement System (CWS-CARES) through June 30, 2022.
