Request for Proposal (RFP) Background

- 1991: Sonoma County established an Exclusive Operating Area (EOA) to serve the cities of Santa Rosa, Sebastopol, Rohnert Park, Cotati, and the surrounding unincorporated areas.
- October 2019: RFP development process commenced including extensive stakeholder engagement.
- November 2021: Final Board approval of RFP after incorporating recommendations from Cal Emergency Medical Services Authority (EMSA), Board Ad-Hoc, and stakeholders. RFP released to stakeholders.

Request for Proposal (RFP) Background

- February 2022: Prior to Final Filing Date, County rescinded the RFP due to worsening supply chain problems and labor shortages in the skilled medical staffing sector.
- February 2022 October 2022: Staff continued to solicit stakeholder feedback and updated RFP.
- October 10, 2022: Sonoma County Board of Supervisors approved a final RFP and directed staff to submit it to the State Emergency Medical Services Authority.

Timeline since October 18, 2022, Board Approval

- November 1, 2022 County sent Request for Proposal (RFP) to State Emergency Medical Services Authority (EMSA) for final approval. State EMSA approved with no modifications.
- November 3, 2022 County Purchasing released the RFP on the County Supplier Portal.
- November 14-15, 2022 County received two letters of intent to propose; one from American Medical Response West and one from Sonoma County Fire District.

Timeline since October 18, 2022, Board Approval

- December 16, 2022 County responds to Proposer's submitted written questions.
- January 17, 2023 County hosts a Proposers Pre-Bid
 Conference to allow potential Proposers to ask questions.
- March 1, 2023 Proposal Due Date. County received two proposals; one from American Medical Response West and one from Sonoma County Fire District.

Timeline since October 18, 2022, Board Approval

- March 6, 2023 First meeting of the Proposal Review Committee
 - Emergency Department Physician, Medical Director for a California Fire District and multiple
 Fire Departments
 - Local Emergency Medical Services (EMS) Agency Administrator
 - Fire Chief from an agency that provides Advanced Life Support transport services
 - Northern California County Administrative Officer
 - Certified Public Accountant with extensive EMS systems knowledge
- April 20, 2023 Proposer Presentations, Final Review Committee Scoring,
 Recommendation to Department of Health Services (DHS) Director
- April 24, 2023 Notice of Intent was released indicating highest scoring proposer
- May 26, 2023 DHS Director recommends awarding contract for ambulance service in Exclusive Operating Area 1 (EOA-1) to Sonoma County Fire District

Protest to the Notice of Intent to Award

- April 28, 2023 American Medical Response West files a protest to the Notice of Intent to Award the contract to SCFD.
 - The protest alleged various legal and conflict of interest violations
- May 2023 Sonoma County Public Infrastructure staff review protest and investigate allegations.
- May 26, 2023 Sonoma County Public Infrastructure Director issues a response, denying American Medical Response West protest.

Committee Recommendation to the DHS Director

- Committee unanimously recommended to the DHS Director that Sonoma County Fire District (SCFD) be selected as the EOA-1 ambulance contractor.
 - All Committee Members stated that patient fees and the inability to assess American Medical Response West's (AMR) fiscal sustainability were the primary differentiating factor.
 - All Committee Members stated that AMR did not meet minimum qualifications requirements (Financial Conditions) by not submitting audited financial statements.
 - Committee Members unanimously agreed that SCFD provided better answers during the Proposer presentations.

DHS Director's Recommendation to the Board

- The DHS Director asks the Board for authorization to execute a 5-year contract for emergency ground ambulance service in Sonoma County Exclusive Operating Area 1 (EOA-1) with Sonoma County Fire District (SCFD) in a form approved by County Counsel that includes an option to extend for an additional 5 years.
 - Consistent with provisions in the Emergency Medical Services Ordinance, SCFD had the highest score among all Proposers in a fair and unbiased competitive process.
 - SCFD's proposal represents the best value to the residents of Sonoma County.
 - The Proposal Review Committee unanimously recommended that the County award the ground ambulance contract in EOA-1 to SCFD.
 - Awarding the ground ambulance contract to SCFD preserves exclusivity in EOA-1 and provides Sonoma County anti-trust immunity by the State.

Questions
