SUBJECT: LIST OF QUALIFIED CONSULTANTS FOR ENGINEERING AND DESIGN

SERVICES FOR WELDED STEEL WATER TANK REHABILITATION - NOT

TO BE USED FOR FEDERALLY FUNDED PROJECTS

Sonoma County Water Agency (Sonoma Water) requires professional engineering design services related to the rehabilitation of welded carbon steel water storage tanks.

Services may include but are not limited to the following:

- a. Reviewing available data including tank record drawings, maintenance records, inspection reports, hazard assessments, and geologic studies.
- b. Identifying and clarifying data gaps critical for tank rehabilitation design.
- c. Conducting supplemental geologic, geotechnical, and geophysical site characterizations, assessments, and analyses to confirm appropriate seismic design criteria.
- d. Assessing the condition of existing structural and non-structural tank components.
- e. Conducting seismic and structural analyses in accordance with applicable standards.
- f. Developing seismic and structural tank rehabilitation alternatives and accompanying design calculations, cost estimates, plans, and specifications.
- g. Assessing the condition and effectiveness of existing coating and cathodic protection systems.
- h. Assessing the condition of existing tank surfaces and coatings, evaluating surface preparation and recoating options, including required level of surface preparation on interior and exterior surfaces, and developing appropriate construction specifications.
- h. Developing engineering drawings, details, and specifications for tank rehabilitation and recoating projects.
- i. Assisting with environmental compliance and permitting related to tank rehabilitation and recoating efforts.

On June 1, 2021, Sonoma Water issued a Request for Statements of Qualifications (RFQ) to the firms listed in the attached Recipient List.

The RFQ was also posted on the Sonoma Water and County of Sonoma Purchasing Department websites.

The six firms listed below submitted Statements of Qualifications (SOQs):

- Thoroughness of SOQ
- Professional qualifications and demonstrated ability to perform the work
- Exceptions to standard terms in the sample agreement
- Local Service Provider Preference
