Honoring and Acknowledging Pip Marquez de la Plata, Founding Councilmember, Lower

Russian River Municipal Advisory Council For Six Years of Exemplary Public Service to the

People of Rio Nido and the Lower Russian River

Whereas, the Lower Russian River Municipal Advisory Council recognizes the profound impact of dedicated individuals who commit themselves to public service and the well-being of their communities; and

Whereas, Pip Marquez de la Plata has faithfully served the Lower Russian River Municipal Advisory Council since his appointment as a founding member in 2018, demonstrating steady commitment and strong leadership; and
