Subrecipients (and any Second-Tier Subrecipients) must comply with all applicable laws, regulations, policies, and official DOJ guidance (including specific cost limits, prior approval and reporting requirements, where applicable) governing the use of

night up to six weeks, covering costs of a weekly panty food bag, utilities, supplies, and cleaning upon exiting; 3) \$57,348 to VOICES will provide comprehensive case management to 18-24 year-old victims of crime by connecting them to resources and supporting them with one-on-one coaching.

4) \$34,320 for an outreach worker from Ruthless Kindness, a mobile veterinary nonprofit serving victims of violence and their pets, will provide additional avenues of outreach with their mobile clinic, providing the opportunity to connect with those who may not initially seek services for themselves, but connect through seeking services for their pet.

The remaining operating costs include client services for emergency housing and supplies, outreach, a cell phone allowance for Verity's full-time Outreach Worker, and mileage for outreach workers.

B. How funds minimize administrative costs and support direct services

Allocations requested will be used to fund direct services as the priority for the program. The grant award will be dedicated to employee salaries, benefits, and operating expenses to include services of participating staff who are not employed by this applicant. No indirect costs are requested. The project budget supports three contracted Outreach Workers to provide outreach and link crime victims to services. Outreach includes visits to sites where homeless individuals

congregate to identify and serve homeless victims of crime that may have disabling conditions. The contracted Housing Case Manager will provide assistance to homeless victims of crime with housing navigation, assistance completing applications, and job-seeking support. A full-time Homeless Outreach Coordinator provides support for the Outreach Workers as well as supporting the broader Victim Services Steering Committee (VSSC) initiative, including data collection.

C. How shared costs are allocated.

The budget does not include shared costs.

D. How staff duties and time support the objectives and activities.

All grant-funded staff duties and time commitments directly support the proposed objectives and activities of the VSSC plan. The 1.0 FTE Homeless Outreach Coordinator is fully dedicated to this grant, providing direct services to victims/survivors who are homeless, including accessing shelter or housing, coordinating outreach and education efforts, and continuing to build relationships with other service providers. Problem Statement

Sonoma County, located on the northern coast of California, comprises nearly 16,000 square miles of land and water. Sonoma County ranges from very small coastal rural communities to the increasingly urban City of Santa Rosa where the majority of the population resides and works. Despite the attractive quality of life, the shift from a somewhat rural community to an urban community has presented challenges in addressing crime trends in this County. Today the population is estimated to be over 500,000 Sonoma County residents. The majority of new residents, 69%, live within the boundaries of Sonoma County's nine cities. The City of Santa Rosa is the county seat and has led this growth in total population, adding 15,841 residents, over ten years to attain its current population of 176,938.

Victim Services has been part of the District Attorney's Office since 2002 and is based at the Sonoma County Hall of Justice (HOJ). The Homeless Outreach Team formed in 2016 with funding from the original XC grant and is housed at the Family Justice Center Sonoma County (FJCSC), which is walking distance from the HOJ. The Homeless Outreach Team provides direct outreach to homeless victims of crime focusing on those experiencing disabling mental,

emotional, and physical conditions. Outreach workers resolve immediate needs for support, engage individuals in a vulnerability assessment, and link victims to ongoing, comprehensive care as well as to prosecution and restitution. The project seeks to coordinate care to homeless victims of crime throughout Sonoma County and to broaden community understanding of the scope and nature of crimes against the homeless. This team is comprised of a coordinator from Victim Services and four outreach workers, one each community base agency; Verity, The Living Room, Ruthless Kindness and VOICES. In the past year our outreach advocate partners have shifted as a previous partner, Catholic Charities, stepped back from the grant to handle their own organizational capacity concerns. This change has resulted in program staff actively spending time networking with various community-based organizations to assist the Homeless Outreach Team in filling any gaps in service. Our goal for the upcoming year will be to fill the gaps created with the loss of other funding sources; assist all victims of crime, from young teens to older adults, who are homeless or at risk of becoming homeless as a result of a victimization.

Verity strives to eliminate all forms of violence in Sonoma County, with a special focus on sexual assault and abuse. Verity facilitates healing and promotes the prevention of violence by providing counseling, advocacy,

intervention, and education in our community. They have a 24-hour hotline, support groups, and assist victims of human trafficking. The Living Room, provides services to homeless women and children who are experiencing homelessness or may be at risk of becoming homeless. A provider of services in our community for the past 29 years, The Living Room holds two sites, one for residential and administrative services, and the Life Center, a hub for services during regular business hours that allows individuals to be connected to local partners, food, and transitional housing programs. The Living Room seeks to increase services where gaps have been identified. The partnership with The Living Room has allowed victims to benefit from Gap Housing. While there is a set exit date from The Living Room's housing options, which would coincide with the victim securing a longer term or permanent housing situation. While in their program, which could last one night or up to six weeks, victims have the opportunity to catch a respite, focus on their job, and receive immediate housing support and food. In addition, victims can interview with the Living Room staff for their transitional housing program for up to a one year stay.

Due to the increase in crime relating to young children, the need for services continues to grow. While there are agencies that focus on childrens' services, there is limited coordination efforts between agencies and

government. The existing services are inadequate to meet the needs without an integrated effort by Community Based Organizations to collaborate with government agencies. There is no process to ensure that all dependent homeless youth have access to services.

<u>Plan</u>

In an innovative approach, Victim Services and VOICES are joining in partnership to continue working on a more comprehensive approach at serving young victims of crime at risk being homeless or aging out of the foster system.

VOICES Sonoma County has been a resource for over 12 years. It offers kids and young adults, who are living on the street or coming out of foster care, a safe place to get connected to food, shelter, clothing, and services available through various partnership like SAY, Our Village Closet and TLC, among others.

VOICES runs a peer-lead program in which a one of-a kind Youth
Engagement Model is implemented. VOICES' comprehensive case
management is designed to prepare 18–24 year-old youth for emancipation by
connecting them to resources and supporting them with one-on-one coaching.
Together, the Case Managers and youth complete an assessment of the youth's
needs and identify local resources to meet these needs. The Case Managers

and youth identify permanent connections with supportive adults, work to create one unified emancipation plan and work in partnership to progress towards the youth's goals. Case Managers ensure the youth accesses core education, career development, health and safety, mentoring, daily living skills, financial resources, housing information, and social connections. VOICES Case Managers work with youth at VOICES as well as at multiple group homes, a variety of Sonoma County schools, Petaluma Family Life Center, SAY Dream Center, Valley of the Moon Children's Home, and Sonoma County Juvenile Hall.

VOICES Youth Advocates provide exceptionally effective support to their peers while guiding the evolving vision of the VOICES Center, training social service agencies in how to best support young people, and advocating as a voice for youth the community. With their "by any means" mindset towards case management and coaching, Advocates, all of whom have lived experience with homelessness, foster care, and/or juvenile justice systems, are uniquely equipped to motivate young people and connect them to resources. A goal of the new partnership is to provide gap housing to victims of crime. After the immediate shelter situation has been met via hotel stays, female victims will be connected to services through The Living Room. The goal will be to reduce the

possibility of female victims feeling like they have no viable options after the initial crisis situation.

The population we serve, namely Sonoma County families and individuals who are victims of crime experiencing homelessness, have also endured collective, community trauma due to the pandemic and fires. The County's resources overall were down during shelter in place and many teams were unable to do outreach in the field. Additionally, shelter bed spaces available in the county are severely limited in comparison to the need for those experiencing homelessness. During the past year, local shelter capacity has varied and not reached pre-pandemic levels despite a rise in the number of homeless individuals and families. To compound this issue, many agencies have struggled with chronically low staffing which impacts service delivery and availability. The Homeless Outreach team has had to adjust to the everchanging dynamics of the local resource network. For clients with transportation issues, this led to a gap or barrier. The virtual world unfortunately created unprecedented challenges when working with such a vulnerable population. On top of that, local need for mental health services has required individuals to get on waitlists that can be a yearlong, which is not ideal for someone actively in a crisis.

Connecting with our service population after lockdowns have been lifted has proven to be difficult. Outreach protocol has changed to adjust for remaining COVID-19 precautions, and events or drop-in times have not been able to reach the same level of attendance that they did pre-pandemic. Due to this, the team has had to adapt and prioritize networking even more to develop relationships for referrals and connections to services. Outreach events are not as regular as they previously were, reaching individuals to learn about services has served as a challenge. As homelessness and certain crimes such as domestic violence and hate crimes have been on the rise, many community partners have turned to the Homeless Outreach Team as a critical asset in assisting these individuals.

The anticipated impact of this funding will focus on salary and benefits to the five staff members working under this grant. Additional funds will go towards mileage, short-term motel stays, gap housing, and food vouchers. This will allow the team to continue efforts that have already been established in the community and address gaps and needs for victims of crime. The need this program addresses holds a high value with victims and community partners

since other programs offering similar benefits impose higher barriers or requirements.

To address the need for an additional advocate, the Homeless Outreach Team is working to hire a new part-time advocate through community-based agency Ruthless Kindness who is the mobile veterinary nonprofit serving victims of violence and their pets. Not only will this expansion to the team provide additional supportive services to victims, it will allow for more avenues of outreach through their mobile clinic outreach events throughout the county, opening the door to connect with those who may not initially seek services for themselves, but get connected through seeking services for their pet.

The Office of the District Attorney's Victim Services Division will continue to administer the XC Grant Subaward and act as the single point of contact for the grant. A process has been established between the Victim Services Director, grant analyst, and the accounting department to approve and pay invoices monthly to the three partners.

To continue expanding services throughout the county, the plan includes utilizing partner spaces and outreach opportunities that will become an

extension of the District Attorney's Victim Services Division. By providing trainings to The Living Room Life Center staff and The Living Room Housing advocate on the Homeless Outreach team about what services the District Attorney's Office can provide victims, as well as victims' rights and resources, these partner sites are able to assist in navigating victims to the proper resource channels.

Additionally, Homeless Outreach Staff stationed at the Family Justice

Center act as a point of contact for Coordinated Entry Intakes which allows
victims to access countywide housing opportunities. By being an access site for
this system, staff participates in weekly case-conferencing calls with homeless
service providers throughout the county. Not only does this continue to include
this program into the greater coordination of care in our community, it allows for
continued networking and wraparound support for each victim. This system has
allowed for victim services to participate in a larger effort to include victims of
domestic violence into the homeless data reporting system while allowing them
to still remain anonymous and confidential in the system.

While the recent partnership addition of The Living Room allowed for access to gap and transitional housing for victims, the need for shelter still remains one of the largest issues in the county. The Homeless Outreach Team

continues to work at identifying different organizations, resources, and creative opportunities to meet the shelter and housing needs of victims. This includes strengthening our relationship with other county programs that offer forms of shelter including the Housing Support Program through CalWorks, as well as the local Housing Authority. For short term solutions to this issue, the program has agreed going forward to provide additional hotel nights for particular victims when there is no other option and safety is a concern.

Ongoing objectives and activities for the grant include:

- Continue to contact new crime victims to provide advocacy, resources, and housing assistance
- Increase Coordinated Entry enrollment by ten percent and maintain active status for all enrolled through the program
- Increase follow-up to clients through case management and continue to track data and trends for services provided
- Continue to provide community outreach and education presentations focused on reaching underserved victim populations
- Enhance emergency assistance by providing clothing, toiletries, and first aid supplies

- Purchase and distribute fuel, bus, and ride share gift cards for transportation needs
- Offer short-term motel stay as needed for clients
- Increase outreach efforts to Transitional Aged Youth (TAY) by five percent
- Increase referrals from health care providers by offering trainings
- Maintain participation in community workgroups for economic justice to provide victims with long term solutions, including a local homeless employment program

Since the implementation of COVID-19 pandemic restrictions, our office has not pursued volunteers to assist our efforts at this time. In lieu of securing volunteers, our efforts have focused on reconnecting and strengthening relationships in the community, especially to reflect the need we have seen through our services. This has included strengthening our relationships with Communique Interpreter Services, Humanidad, and La Luz to assist the increased number of monolingual Spanish and American Sign Language speaking clients that are being served by the Homeless Outreach Team.

The Victim Services Division collaborates with other county departments, law enforcement, and community agencies. Victim Services Operational Agreements are in place. We have excellent working relationships with these agencies providing training and collaborating on numerous outreach events. The Victim Services Director and staff are part of many multi-disciplinary Teams including the Family Violence Prevention Council, Human Trafficking Task Force, Redwood Children Center Multidisciplinary Team (MDT) meeting, Elder Abuse MDT meeting, Elder Protection Workgroup, Homeless Employment Workgroup, and the Domestic Violence Death Review.

Homeless Outreach Team staff are consistently provided with opportunities for continued training and education focusing on topics such as Trauma Informed Services, Serving Victims with Disabilities, Harm Reduction, Fair Housing, and Cultural Competencies specifically with Tribal Engagement. Given the diverse population that is served through the outreach team, the team prioritizes trainings that reflect the latest knowledge and understanding of the current diversity, equity, and inclusion standards.


