Good morning Sonoma County Board of Supervisors,

I am asking for postponement of this critical vote on the County Zoning Ordinance Revision.

These ordinance revisions will include:

1. Elimination of the Board of Zoning Adjustments (BZA) and the Project Review and Advisory Committee (PRAC);
2. Establishing a Zoning Administrator to handle what would be considered “minor” vs. “major” projects;
3. Establishing the criteria of 25 Average Daily Trips to determine how projects would be processed. Proposing to use 25 ADT (Average Daily Traffic) as a key criteria to determine project impacts and the process for PRMD review is a dangerous oversimplification. *There is no rational or empirical basis for using Average Daily Traffic as the sole criteria for deciding how to process an application. Why is 25 ADT and not 50 or 100 ADT proposed? Furthermore, ADT is inapplicable to a wide variety of projects. For example, timber harvesting; projects that impact groundwater availability; or projects within sensitive areas of the Coastal Zone which have no functional or quantifiable relationship to ADT.*

These proposed changes would deny the due process which is in our constitution.
