## 2023 Proposed Update to County of Sonoma Tobacco Retail License: Proposed Expansion of Youth Oriented Areas Definition and Impacts on Current Retailers


The Department of Health Services' Impact Sonoma Tobacco Prevention Program is proposing an expansion to definition of *youth-oriented areas* in the tobacco retail license ordinance (Sonoma County Code, Chapter 32A). This policy change would bring this definition in alignment with other tobacco retail licenses (TRL) ordinances in the County. The current definition includes only K-12 schools. The proposal is to expand the definition to include public libraries, playgrounds, youth centers, recreation facilities open to the public or a private community, a licensed childcare facility or preschool (does not include small and large family day care homes)<sup>3</sup>.


This definition is important for current retailers as it is the basis for how tobacco retail licenses can be transferred. While all retailers can transfer their tobacco licenses, a retailer located within a 1,000 foot buffer zone of a youth sensitive area is subject to different rules. These retailers are allowed to transfer their tobacco license only to an immediate family member<sup>1</sup>. Of note, this license transfer limitation also applies to retailers that sell the most tobacco products, defined in the policy as Significant Tobacco Retailers<sup>2</sup>, regardless of their proximity to a youth-oriented area.

This definition also pertains to *new* tobacco retail license holders as new licensees are not allowed to be located within 1,000 feet of youth-oriented areas. Currently, this is not relevant because new licenses are not being issued as the number of licensed retailers has not dropped below the density limit (1 retailer per 2,000 population) stated in the policy.

Currently, nine retailers are subject to the tobacco license transfer limitation. The proposed update to the youth-oriented areas definition would add 24 retailers, bringing the total to 33. Figure 1 demonstrates that most retailers (54 or 69%) will be unaffected by the proposed definition change. Figure 2 shows that 43% of retailers will be subject to a license transfer limitation if the change goes into effect.

Table 1 below provides a listing of the businesses that would be newly affected by the proposed definition change to youth-oriented areas. Table 2 lists the current tobacco retailers subject to the transfer limitation.

Under the current policy, a total of nine retailers are subject to the transfer limitation: six are within a K-12 school buffer zone, four are Significant Tobacco Retailers, and one retailer is both.

## **Definitions:**

- (1) a private or public kindergarten, elementary, middle, junior high, or high school;
- (2) a library open to the public;
- (3) a playground open to the public;
- (4) a youth center, defined as a facility where children, ages 6 to 17, inclusive, come together for programs and activities;
- (5) a recreation facility open to the public, defined as an area, place, structure, or other facility that is used either permanently or temporarily for community recreation, even though it may be used for other purposes;
- (6) a recreation area open to the public or to all the residents of a private community;
- (7) a licensed child-care facility or preschool [other than a small-family day care home or a large-family day care home [as defined in California Health & Safety Code§ 1596.78]]
