# **Executive Summary:**

The Independent Office of Law Enforcement Review and Outreach (IOLERO) was established by county ordinance in 2016, and expanded in 2020 by Measure P. The operational mission of IOLERO is to strengthen the relationship between the Sonoma County Sheriff's Office (SCSO) and the community it serves through outreach and the promotion of greater transparency of law enforcement operations.

To accomplish this goal, IOLERO audits certain complaints against the SCSO, directly investigates a smaller set of high-consequence SCSO incidents and makes policy and training recommendations based on those audits and investigations. IOLERO also works with a Community Advisory Council (CAC) to conduct comprehensive community engagement, promote community-driven policy recommendations, support systemic reform, and build community partnership in law enforcement operations.

Today the Board is requested to receive the Fiscal Year 2022-23 IOLERO Annual Report which covers the period from July 2022 - June 2023.
