FIRST AMENDMENT

TO

PROFESSIONAL SERVICES AGREEMENT

This First Amendment ("Amendment"), dated as of November 1, 2024, is by and between the County of Sonoma, a political subdivision of the State of California ("County"), and the Center for Volunteer and Nonprofit Leadership (CVNL), a California nonprofit 501(c)(3) Corporation, hereinafter referred to as ("Contractor").

RECITALS

WHEREAS, County and Contractor entered into that certain Agreement, dated May 1, 2023, for court referral services for a volunteer referral program experienced in assigning community service work to adults and juveniles involved in County's criminal justice system; and

WHEREAS, County and Contractor desire to amend the Agreement for the purposes of extending the term for the first one (1) year period on the same terms and conditions set forth herein,

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

AGREEMENT

- 1. The County is hereby exercising its option per Article 3. Term of Agreement to extend this Agreement for the first additional period. The Term of Agreement shall be extended from November 1, 2024, through October 31, 2025; and
- 2. Except to the extent the Agreement is specifically amended or supplemented hereby, the Agreement, together with exhibits is, and shall continue to be, in full force and effect as originally executed, and nothing contained herein shall, or shall be construed to modify, invalidate, or otherwise affect any provision of the Agreement or any right of the County arising thereunder.
- 3. This Amendment shall be governed by and construed under the internal laws of the state of California, and any action to enforce the terms of this Amendment or for the breach thereof shall be brought and tried in the County of Sonoma.

COUNTY AND CONTRACTOR HAVE CAREFULLY READ AND REVIEWED THIS AMENDMENT AND EACH TERM AND PROVISION CONTAINED HEREIN AND, BY EXECUTION OF THIS AMENDMENT, SHOW THEIR INFORMED AND VOLUNTARY CONSENT THERETO.
