1. PROBLEM STATEMENT

From January 1, 2018 through December 31, 2022, there were 318 total crashes involving 470 children under the age of 8, killing 1 and injuring 201 kids in Sonoma County. Just 21 (10%) of injured children were involved in pedestrian, bicycle, or motorcycle crashes. According to SWITRS, a child restraint in the vehicle was used in only 2/3 (67%) of crashes, despite being required 100% of the time for children under age 8 riding in motor vehicles. This indicates a need for additional child safety equipment. In a suburban/rural county such as Sonoma, with limited public transit availability, motor vehicles are the overwhelming first choice of transportation for families. With increased inflation and an extremely high cost of living, many families are faced with heart-wrenching decisions daily, including whether to spend hard-earned wages on food and rent or other essentials such as car repairs, childcare, and school supplies. Although there were 0 fatalities among young children from 2018-2021, there was one infant fatality reported in 2022.

Although the Department of Health Services currently runs a low-cost car seat program for low-income families through fees collected from child restraint law violations, the program is centralized in Santa Rosa, making access difficult for families in remote areas of the county. Additionally, the Health Department is serving fewer community members due to a reduced number of cited violations and associated fines. By pairing distribution of no-cost child safety seats with perinatal and pediatric visits, families will be able to receive a no-cost, age and size appropriate child safety seat through a trusted medical provider at a previously scheduled appointment rather than waiting for an appointment to become available with the Department of Health Services, or resorting to a used seat (purchased or hand-me-down) that may be expired or missing parts.

2. PERFORMANCE MEASURES

3. METHOD OF PROCEDURE A. <u>Phase 1 – Program Preparation (1st Quarter of Grant Year)</u> <ul style="list-style-type: none"> Develop operational plans to implement the “best practice” strategies outlined in the objectives section. All training needed to implement the program should be conducted in the first quarter. All grant related purchases needed to implement the program should be made in the first quarter. <u>Media Requirements</u> <ul style="list-style-type: none"> Issue a press release approved by the OTS PIO announcing the kick-off of the grant by November 15, but no sooner than October 1. The kick-off release must be approved by the OTS PIO and only distributed after the grant is fully signed and executed. B. <u>Phase 2 – Program Operations (Throughout Grant Year)</u> <u>Media Requirements</u> The following requirements are for all grant-related activities: <ul style="list-style-type: none"> Send all media advisories, alerts, videos, graphics, artwork, posters, radio/PSA/video scripts, storyboards, digital and/or print educational materials for grant-related activities to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator. Addendum:

We plan to promote National Child Passenger Safety Week in September 2025 through a number of social media posts, and will encourage our subcontractors to share our content to reach the widest possible audience. The MCAH Director will be responsible for ensuring all media requirements are met, and coordinating with the OTS PIO. MCAH Director will work with DHS fiscal staff to submit quarterly fiscal and performance reports.

4. METHOD OF EVALUATION

Using the data compiled during the grant, the Grant Director will complete the “Final Evaluation” section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant’s accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

PERSONNEL COSTS

No employee, officer, or agent of a State or its subrecipient who is authorized in an official capacity to negotiate, make, accept, or approve, or to take part in negotiating, making, accepting, or approving any subaward, including contracts or subcontracts, in connection with this grant shall have, directly or indirectly, any financial or personal interest in any such subaward. 1. The recipient shall disclose any conflict of interest identified as soon as reasonably possible, making an immediate and full disclosure in writing to NHTSA. The disclosure shall include a description of the action which the recipient has taken or proposes to take to avoid or mitigate such conflict.
2. NHTSA will review the disclosure and may require additional relevant information from the recipient. If a conflict of interest is found to exist, NHTSA may (a) terminate the award, or (b) determine that it is otherwise in the best interest of NHTSA to continue the award and include appropriate provisions to mitigate or avoid such conflict.
3. Conflicts of interest that require disclosure include all past, present, or currently planned organizational, financial, contractual, or other interest(s) with an organization regulated by NHTSA or with an organization whose interests may be substantially affected by NHTSA activities, and which are related to this award. The interest(s) that require disclosure include those of any recipient, affiliate, proposed consultant, proposed subcontractor, and key personnel of any of the above. Past interest shall be limited to within one year of the date of award. Key personnel shall include any person owning more than a 20 percent interest in a recipient, and the officers, employees or agents of a recipient who are responsible for making a decision or taking an action under an award where the decision or action can have an economic or other impact on the interests of a regulated or affected organization.

PROHIBITION ON USING GRANT FUNDS TO CHECK FOR HELMET USAGE

The State and each subrecipient will not use 23 U.S.C. Chapter 4 grant funds for programs to check helmet usage or to create checkpoints that specifically target motorcyclists.
