# Overview of NOFA

- \$3 million available for CBOs or jurisdictions
- All projects must be housing focused
- Priorities include: shared housing or master lease programs, non-congregate shelter, 24/7 safe parking, PSH programs, other housing focused interventions
- CoC Board provided consultation in April 2023 and Board of Supervisors makes final determinations
- 12 applications received for a total of \$8,164,398

# Scoring Schema

- Staff from DHS Homelessness Services and Policy, Planning and Equity teams scored projects based on NOFA priorities
  1. Overall Proposal and Program Quality (30 points)
  2. Type of Proposal/Program and if existing or in developmental stage (10 points)
  3. Program's Operation Plan, including achievable budget and housing focus (30 points)
  4. Adherence to NOFA (10 points)
  5. Geographical need (20 points)
