**Executive Summary:**

On January 10, 2025 the Board held a meeting to conduct their annual review and discussion on calendar year priorities. Based on input provided by the departments and the discussion held by the Board, staff is presenting for approval the 2025 Significant Items of Interest Calendar.

Consistent with the Board's Strategic Plan Racial Equity and Social Justice pillar, and to look for opportunities to operationalize equity several of the Significant Items programmed for the year will be reviewed through the Racial Equity Toolkit (Attachment C), developed by the Government Alliance on Race and Equity (GARE), and approved by the Board in November 2020.
