**Recommended Action:**

Approve a resolution supporting the participation of Mr. Brad Sherwood as a Board Member on the Region One Board of Directors of the Association of California Water Agencies during the 2022-2023 term.

**Executive Summary:**

The Association of California Water Agencies has issued a call for nominations for Board members of the Region One Board of Directors. General Manager Grant Davis has requested that Community and Government Affairs Division Manager Brad Sherwood continue to serve on the Association of California Water Agency's Region One Board of Directors. The Association of California Water Agencies requires that nominees submit an official resolution of nomination from the Sonoma County Water Agency indicating its support for the nomination and signed by an authorized signatory.

If elected, Mr. Sherwood would serve as a Board Member of the Region One Association of California Water Agencies Board of Directors for two years beginning January 1, 2022, through December 31, 2023.
