SUBJECT: Selection of Water Systems Consulting for Engineering and Design Services

for Occidental County Sanitation District to Graton Pipeline Design Project

Occidental County Sanitation District (District) has been severely challenged to provide affordable wastewater services to its small customer base and relies on subsidies received from Sonoma County Water Agency (Sonoma Water) to provide a substantial portion of its operating and capital improvement costs. Graton Community Services District (Graton) approached District several years ago to express interest in providing wastewater treatment and disposal services to District. Based on a feasibility study conducted by District, there is potential for both Graton and District to realize significant benefits by connecting their systems together via the Occidental County Sanitation District to Graton Community Service District Wastewater Transfer Pipeline Project.

On July 27, 2022, District issued a Request for Proposals (RFP) to the following 50 firms:

The three firms listed below submitted Proposals.

- Water Systems Consulting, Folsom, CA

The following criteria, listed in order of importance, were used to evaluate each firm:

- Professional qualifications and demonstrated ability to perform the work.
- Responsiveness to the work requirements.
- Exceptions to standard terms in the sample agreement.
- Thoroughness of proposal.

Water Systems Consulting (Consultant) was selected to perform the work because Consultant demonstrated in-depth knowledge of sewer force main and pump station design criteria, project challenges, approaches to overcoming hydraulic concerns, and a familiarity with operation limitations. Ultimately, the interview team believed that Consultant provided a clear and thorough proposal organized by tasks which exhibited Consultant's ability to perform the work within the allotted timeframe and budget.

Proposals and evaluation forms have been sent to Records.

The hiring of Consultant for this agreement causes no conflict of interest and is not based on any financial incentive provided to Sonoma Water or its employees and representatives.
