# RESOLUTION OF THE FIRE MEMORIAL TASK FORCE ADOPTING A CONFLICT OF INTEREST CODE

WHEREAS, the Political Reform Act, Government Code sections 81000 et seq., requires state and local government agencies to adopt conflict of interest codes, and

WHEREAS, the Fair Political Practices Commission has adopted a regulation, 2 Cal. Code of Regs. Section 18730, which contains the terms of a standard conflict of interest code and which can be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments to the Political Reform Act, and

WHEREAS, the Task Force wishes to adopt this standard code and designate which officers and employees should disclose financial interests and describe which interests must be disclosed, and

#### NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The terms of 2 Cal. Code of Regs. Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference and, along with the attached Appendix A and Appendix B, in which members and employees are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the Fire Memorial Task Force, and
- 2. Pursuant to Section 4 of the standard code, Task Force members shall file statements of economic interest electronically with the Clerk of the Sonoma County Board of Supervisors. Any District board member or other designated employee already required to submit a disclosure statement (Form 700) pursuant to Government Code section 87203 may submit a copy of that statement in lieu of any filing required by this code provided that no additional disclosure would be required by this code.

Such written determination shall include a description of the consultant's duties and based upon that description, a statement of the extent of the disclosure requirements. The Chairperson's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code.

## Disclosure Categories<sup>1</sup>

<u>Category 1</u>: All investments, business positions and sources of income, including gifts, loans and travel payments; all interests in real property.

<sup>&</sup>lt;sup>1</sup>Only investments in and sources of income from business entities, and sources of income, which do business in the geographic area of the Task Force, or real property interests located in the Task Force's jurisdiction, need to be reported.
