The Department of Emergency Management is working in collaboration with Fire Safe Sonoma, local public safety agencies and emergency management partners on The Wildfire & Earthquake Safety Expo 2025, countywide disaster preparedness event at the Sonoma County Fairgrounds. While this is the Expo's 4th year, this is the first year for the event in Santa Rosa. It has been moved to this more central location to make attendance easier for a larger portion of the county and grow participation, and overall preparedness in the County.

The event aims to improve disaster preparedness knowledge and resilience among all Sonoma County residents, ensure bilingual and culturally competent outreach to increase participation from Spanish-speaking, farmworker, and low-income families, enhance coordination between emergency responders, community-based organizations, and local businesses to foster a culture of preparedness, and promote equitable access to disaster preparedness resources, particularly for historically marginalized communities.

2. Data: What's the data? What does the data tell us?

- A. Yes, the Expo targets all of Sonoma County, with specific outreach efforts in high-risk wildfire zones and low-income communities.

 In past years, over 20% of attendees were Spanish-speaking farmworker families, highlighting the need for bilingual resources and culturally relevant preparedness training. Based on the latest Portrait of Sonoma, Sonoma County's population includes approximately 58% White, 29% Latinx, 5% Asian/Pacific Islander, and 2% Black residents.
- **B.** Latinx and low-income communities face higher disaster vulnerability due to language barriers, limed access to emergency alerts and economic constraints that prevent preparedness investments. Past disasters in the county have disproportionally impacted communities with lower Human Development Index (HDI) scores, where financial hardship makes personal/family preparedness difficult.
- **C.** Performance-level data from the previous expos and preparedness events show that bilingual outreach and partnerships with local organizations increase engagement among marginalized groups, as attendance has increased year after year.
- **D.** There are gaps in the data, however the County does not track granular data on household emergency preparedness levels in the community. As there is no requirement to report data to the County, any requirement to collect, maintain, and/or provide information would likely be burdensome. Yet, tracking of event impact metrics, such as post-event preparedness actions taken by Expo attendees would be beneficial.

3. Community Engagement: How have communities been engaged? Are there opportunities to expand engagement?

- a. Who are the most affected community members who are concerned with or have experience related to this proposal? How have you involved these community members in the development of this proposal?

- **A.** The Wildfire and Earthquake Safety Expo is open to the whole community. Outreach is extended through different methods of communication, media/print, social media, and newsletters. There is also targeted outreach and advertisement to Spanish-speaking and farmworker communities through community-based organizations and service providers.
- **B.** Providing messaging for community champions who can then provide word-of-mouth to residents about the benefits of attending: increased access to disaster preparedness information and resources and strengthened community trust and partnerships with public safety agencies.
- C. Racial inequities in disaster preparedness stem from language barriers, economic disparities, and historical underrepresentation in emergency planning. Language barriers hinder Spanish-speaking residents from accessing critical disaster preparedness training, leaving them unprepared in crises. Economic disparities limit access to evacuation resources, transportation, and recovery aid, making it harder for low-income families, especially farmworkers, to respond effectively. Historical underrepresentation in emergency planning fosters mistrust in government-led initiatives, reducing participation and reliance on official preparedness efforts. Addressing these issues requires bilingual communication, financial accessibility, and inclusive planning to ensure equitable disaster preparedness.

4. Analysis and Strategies: What are your strategies for advancing racial equity?

- a. Given what you have learned from research and stakeholder involvement, how will the proposal increase or decrease racial equity? Who would benefit from or be burdened by your proposal?

- A. This proposal increases racial equity by providing bilingual disaster education, ensuring Spanish-speaking and immigrant communities have access to life-saving information. Hosting the event at Santa Rosa Fairgrounds improves accessibility for those facing transportation barriers. Additionally, targeted outreach expands awareness and engagement in historically underserved communities, strengthening overall preparedness.
- **B.** As the proposal is for the allocation of funding for the event, negative consequences directly to the community are unlikely a result of this proposal.
- **C.** To enhance the Expo's impact, outreach will be expanded through trusted messengers, including faith-based groups, non-profits and community-based organizations, and local businesses, ensuring information reaches diverse and underserved communities. Event materials and presentations will be culturally relevant and fully bilingual, ensuring accessibility for both English- and Spanish-speaking residents. These strategies will foster deeper community engagement and improve disaster resilience across Sonoma County.
- **D.** Yes, the impacts are aligned with the intended outcomes of improving disaster preparedness knowledge, ensure bilingual and culturally competent outreach, enhance coordination between emergency responders, community-based organizations, and local businesses to foster a culture of preparedness, and promote equitable access to disaster preparedness resources. The focus on multi-method outreach directly supports these goals.

Partnerships with community organizations, like COAD, will ensure messaging resonates with vulnerable and underserved populations
- C. To sustain racial equity efforts, ongoing coordination meetings with community and service organizations will ensure continuous engagement, feedback, and collaboration. Future preparedness events will be amplified through community-led initiatives and workshops. MOUs with key partners will formalize long-term involvement in emergency planning. Sustainable funding strategies, including grants and public-private partnerships, will support continued outreach. Embedding racial equity goals into emergency management policies will ensure equitable access to preparedness resources for all residents.
