

**MODIFICATION NUMBER TWO OF  
AGREEMENT FOR SERVICES BETWEEN  
COUNTY OF SONOMA AND  
KAREN SMITH, MD  
(Version 2025 Aug 12)**

On October 24, 2024, the County of Sonoma, a political subdivision of the State of California, (hereinafter "County") and Karen Smith, MD (hereinafter "Contractor") entered into a services agreement, modified by the parties effective July 10, 2025 as Modification No. 1 (hereinafter "Agreement").

Pursuant to Section 13.7 (Merger) of the Agreement, the parties hereby evidence their intent and desire to modify the Agreement as follows:

1. Exhibit B (Budget) is hereby deleted and replaced in its entirety with the attached Exhibit B (Budget).
2. Section 2.2 (Maximum Payment Obligation) is hereby revised to read as follows:

2.2. Maximum Payment Obligation

In no event shall County be obligated to pay Contractor more than the total sum of \$165,998 under the terms and conditions of this Agreement.

3. Article 3 (Term of Agreement) is hereby revised to read as follows:

3. Term of Agreement

The term of this Agreement shall be from October 28, 2024 to October 31, 2025, unless terminated earlier in accordance with the provisions of Article 4 (Termination).

Except as expressly modified herein, all terms and conditions of Agreement shall remain in full force and effect.
