TERMINAL APRON RECONSTRUCTION, PHASE 2
ENGINEER OF RECORD (EOR) AND POST CONSTRUCTION SERVICES

May 20, 2025

OVERVIEW

Effective December 6, 2022, MEAD & HUNT, INC. (“Consultant”) and the County of Sonoma (“Owner”) entered into an Agreement for **Standard Professional Services Agreement** (the “Master Agreement”). Pursuant to Section 1.1 of the Master Agreement, Consultant and County may execute task orders by which County requests and Consultant agrees to perform certain professional services. This “**Task Order #20**” is entered into between County and Consultant pursuant to the Master Agreement for Consultant to provide Engineering Design Services for the **Terminal Apron Reconstruction, Phase 2 Engineer of Record (EOR) and Post Construction Services** at the Charles M. Schulz-Sonoma County Airport (Airport) in Santa Rosa, California. The terms of the Master Agreement shall control all work performed hereunder.

This document includes *Exhibit A*, which describes the work to be provided by Consultant for the **Terminal Apron Reconstruction, Phase 2 Engineer of Record (EOR) and Post Construction Services** (Project) to be performed at / for the Charles M. Schulz-Sonoma County Airport, under this Task Order #20.

SUMMARY OF SERVICES

The following summarizes the services that may be provided by the Consultant under this Task Order #20:

COUNTY has contracted with C&S Companies to provide daily construction observation and monitoring for the Project. C&S will also be responsible for coordinating with QA Testing company.

The COUNTY has identified the Construction Manager at Risk (CMAR) delivery method as the preferred approach for ensuring functional phasing, cost stabilization, low operational impacts, and success of the Project. The Construction Manager (CM) team that was selected is Granite Construction, who will provide construction services for the Project.

The Phase 2 construction work to be performed by Consultant under this contract includes the following:

- Demo of existing Asphalt Concrete (AC) paving.
- Demo of existing Portland Cement Concrete (PCC) pavement.
- Removal of existing PCC Tie-Down Anchors and Fencing & Gate.
- AC Paving.
- PCC pavement construction.

- Installation of Electrical GPU.
- Installation of Electrical GSE.
- Installation of Apron Lightning Infrastructure.

See Task Order #20 *Exhibit A* for detailed scope of services.

COMPENSATION FOR SERVICES

The County of Sonoma shall compensate Mead & Hunt, Inc. for services and associated expenses, provided under this Task Order #20, on a **Time-and-Expense** basis not-to-exceed **ONE HUNDRED SEVENTY-FIVE THOUSAND SEVEN HUNDRED FORTY-FIVE DOLLARS (\$175,745)** in accordance with the Consultant's fees included as *Attachment 1, "Mead & Hunt, Inc. Standard Billing Rate Schedule"* to *Exhibit A, Scope of Services*. The fees as stated shall not be exceeded without the prior written authorization from the County.

EXHIBIT 1 to TASK ORDER

ACCESS TO RECORDS AND REPORTS

The Contractor must maintain an acceptable cost accounting system. The Contractor agrees to provide the Owner, the Federal Aviation Administration and the Comptroller General of the United States or any of their duly authorized representatives access to any books, documents, papers and records of the Contractor which are directly pertinent to the specific contract for the purpose of making audit, examination, excerpts and transcriptions. The Contractor agrees to maintain all books, records and reports required under this contract for a period of not less than three years after final payment is made and all pending matters are closed.

BREACH OF CONTRACT TERMS

Any violation or breach of terms of this contract on the part of the *Consultant* or its subcontractors may result in the suspension or termination of this contract or such other action that may be necessary to enforce the rights of the parties of this agreement.

Owner will provide *Consultant* written notice that describes the nature of the breach and corrective actions the *Consultant* must undertake in order to avoid termination of the contract. Owner reserves the right to withhold payments to Contractor until such time the Contractor corrects the breach or the Owner elects to terminate the contract. The Owner's notice will identify a specific date by which the *Consultant* must correct the breach. Owner may proceed with termination of the contract if the *Consultant* fails to correct the breach by the deadline indicated in the Owner's notice.

The duties and obligations imposed by the Contract Documents and the rights and remedies available thereunder are in addition to, and not a limitation of, any duties, obligations, rights and remedies otherwise imposed or available by law.

GENERAL CIVIL RIGHTS PROVISIONS

The Contractor agrees to comply with pertinent statutes, Executive Orders and such rules as are promulgated to ensure that no person shall, on the grounds of race, creed, color, national origin, sex, age, or disability be excluded from participating in any activity conducted with or benefiting from Federal assistance.

This provision binds the Contractor and subcontractors from the bid solicitation period through the completion of the contract. This provision is in addition to that required by Title VI of the Civil Rights Act of 1964.

Compliance with Nondiscrimination Requirements:

During the performance of this contract, the Contractor, for itself, its assignees, and successors in interest (hereinafter referred to as the "Contractor"), agrees as follows:

1. **Compliance with Regulations:** The Contractor (hereinafter includes consultants) will comply with the Title VI List of Pertinent Nondiscrimination Acts and Authorities, as they may be amended from time to time, which are herein incorporated by reference and made a part of this contract.

2. **Nondiscrimination:** The Contractor, with regard to the work performed by it during the contract, will not discriminate on the grounds of race, color, or national origin in the selection and retention of subcontractors, including procurements of materials and leases of equipment. The Contractor will not participate directly or indirectly in the discrimination prohibited by the Nondiscrimination Acts and Authorities, including employment practices when the contract covers any activity, project, or program set forth in Appendix B of 49 CFR part 21.
3. **Solicitations for Subcontracts, including Procurements of Materials and Equipment:** In all solicitations, either by competitive bidding or negotiation made by the Contractor for work to be performed under a subcontract, including procurements of materials, or leases of equipment, each potential subcontractor or supplier will be notified by the Contractor of the contractor's obligations under this contract and the Nondiscrimination Acts and Authorities on the grounds of race, color, or national origin.
4. **Information and Reports:** The Contractor will provide all information and reports required by the Acts, the Regulations, and directives issued pursuant thereto and will permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the sponsor or the Federal Aviation Administration to be pertinent to ascertain compliance with such Nondiscrimination Acts and Authorities and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish the information, the Contractor will so certify to the sponsor or the Federal Aviation Administration, as appropriate, and will set forth what efforts it has made to obtain the information.
5. **Sanctions for Noncompliance:** In the event of a Contractor's noncompliance with the non-discrimination provisions of this contract, the sponsor will impose such contract sanctions as it or the Federal Aviation Administration may determine to be appropriate, including, but not limited to:
 - a. Withholding payments to the Contractor under the contract until the Contractor complies; and/or
 - b. Cancelling, terminating, or suspending a contract, in whole or in part.
6. **Incorporation of Provisions:** The Contractor will include the provisions of paragraphs one through six in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Acts, the Regulations, and directives issued pursuant thereto. The Contractor will take action with respect to any subcontract or procurement as the sponsor or the Federal Aviation Administration may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the Contractor becomes involved in, or is threatened with litigation by a subcontractor, or supplier because of such direction, the Contractor may request the sponsor to enter into any litigation to protect the interests of the sponsor. In addition, the Contractor may request the United States to enter into the litigation to protect the interests of the United States.

Title VI List of Pertinent Nondiscrimination Acts and Authorities

During the performance of this contract, the Contractor, for itself, its assignees, and successors in interest (hereinafter referred to as the “Contractor”) agrees to comply with the following non-discrimination statutes and authorities; including but not limited to:

- Title VI of the Civil Rights Act of 1964 (42 USC § 2000d *et seq.*, 78 stat. 252) (prohibits discrimination on the basis of race, color, national origin);
- 49 CFR part 21 (Non-discrimination in Federally-assisted programs of the Department of Transportation—Effectuation of Title VI of the Civil Rights Act of 1964);
- The Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, (42 USC § 4601) (prohibits unfair treatment of persons displaced or whose property has been acquired because of Federal or Federal-aid programs and projects);
- Section 504 of the Rehabilitation Act of 1973 (29 USC § 794 *et seq.*), as amended (prohibits discrimination on the basis of disability); and 49 CFR part 27;
- The Age Discrimination Act of 1975, as amended (42 USC § 6101 *et seq.*) (prohibits discrimination on the basis of age);
- Airport and Airway Improvement Act of 1982 (49 USC § 471, Section 47123), as amended (prohibits discrimination based on race, creed, color, national origin, or sex);
- The Civil Rights Restoration Act of 1987 (PL 100-209) (broadened the scope, coverage and applicability of Title VI of the Civil Rights Act of 1964, the Age Discrimination Act of 1975 and Section 504 of the Rehabilitation Act of 1973, by expanding the definition of the terms “programs or activities” to include all of the programs or activities of the Federal-aid recipients, sub-recipients and contractors, whether such programs or activities are Federally funded or not);
- Titles II and III of the Americans with Disabilities Act of 1990, which prohibit discrimination on the basis of disability in the operation of public entities, public and private transportation systems, places of public accommodation, and certain testing entities (42 USC §§ 12131 – 12189) as implemented by U.S. Department of Transportation regulations at 49 CFR parts 37 and 38;
- The Federal Aviation Administration’s Nondiscrimination statute (49 USC § 47123) (prohibits discrimination on the basis of race, color, national origin, and sex);
- Executive Order 12898, Federal Actions to Address Environmental Justice in Minority Populations and Low-Income Populations, which ensures nondiscrimination against minority populations by discouraging programs, policies, and activities with disproportionately high and adverse human health or environmental effects on minority and low-income populations;
- Executive Order 13166, Improving Access to Services for Persons with Limited English Proficiency, and resulting agency guidance, national origin discrimination includes discrimination because of limited English proficiency (LEP). To ensure compliance with Title VI, you must take reasonable steps to ensure that LEP persons have meaningful access to your programs (70 Fed. Reg. at 74087 to 74100);
- Title IX of the Education Amendments of 1972, as amended, which prohibits you from discriminating because of sex in education programs or activities (20 USC 1681 *et seq.*).

CLEAN AIR AND WATER POLLUTION CONTROL

Contractor agrees to comply with all applicable standards, orders, and regulations issued pursuant to the Clean Air Act (42 USC § 740-7671q) and the Federal Water Pollution Control Act as amended (33 USC § 1251-1387). The Contractor agrees to report any violation to the Owner immediately upon discovery. The Owner assumes responsibility for notifying the Environmental Protection Agency (EPA) and the Federal Aviation Administration.

Contractor must include this requirement in all subcontracts that exceeds \$150,000.

CONTRACT WORKHOURS AND SAFETY STANDARDS ACT REQUIREMENTS

1. Overtime Requirements.

No contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers or mechanics shall require or permit any such laborer or mechanic, including watchmen and guards, in any workweek in which he or she is employed on such work to work in excess of forty hours in such workweek unless such laborer or mechanic receives compensation at a rate not less than one and one-half times the basic rate of pay for all hours worked in excess of forty hours in such workweek.

2. Violation; Liability for Unpaid Wages; Liquidated Damages.

In the event of any violation of the clause set forth in paragraph (1) of this clause, the Contractor and any subcontractor responsible therefor shall be liable for the unpaid wages. In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages. Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the clause set forth in paragraph (1) of this clause, in the sum of \$10 for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of forty hours without payment of the overtime wages required by the clause set forth in paragraph (1) of this clause.

3. Withholding for Unpaid Wages and Liquidated Damages.

The Federal Aviation Administration (FAA) or the Owner shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (2) of this clause.

4. Subcontractors.

The Contractor or subcontractor shall insert in any subcontracts the clauses set forth in paragraphs (1) through (4) and also a clause requiring the subcontractor to include these clauses in any lower tier subcontracts. The prime contractor shall be responsible for compliance by any subcontractor or lower tier subcontractor with the clauses set forth in paragraphs (1) through (4) of this clause.

COPELAND “ANTI-KICKBACK” ACT

Contractor must comply with the requirements of the Copeland “Anti-Kickback” Act (18 USC 874 and 40 USC 3145), as supplemented by Department of Labor regulation 29 CFR part 3. Contractor and subcontractors are prohibited from inducing, by any means, any person employed on the project to give up any part of the compensation to which the employee is entitled. The Contractor and each Subcontractor must submit to the Owner, a weekly statement on the wages paid to each employee performing on covered work during the prior week. Owner must report any violations of the Act to the Federal Aviation Administration.

DAVIS-BACON REQUIREMENTS

1. Minimum Wages.

(i) All laborers and mechanics employed or working upon the site of the work will be paid unconditionally and not less often than once a week, and without subsequent deduction or rebate on any account (except such payroll deductions as are permitted by the Secretary of Labor under the Copeland Act (29 CFR Part 3)), the full amount of wages and bona fide fringe benefits (or cash equivalent thereof) due at time of payment computed at rates not less than those contained in the wage determination of the Secretary of Labor which is attached hereto and made a part hereof, regardless of any contractual relationship which may be alleged to exist between the Contractor and such laborers and mechanics.

Contributions made or costs reasonably anticipated for bona fide fringe benefits under section 1(b)(2) of the Davis-Bacon Act on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of paragraph (1)(iv) of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics shall be paid the appropriate wage rate and fringe benefits on the wage determination for the classification of work actually performed, without regard to skill, except as provided in 29 CFR Part 5.5(a)(4). Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein: *Provided* that the employer’s payroll records accurately set forth the time spent in each classification in which work is performed. The wage determination (including any additional classification and wage rates conformed under (1)(ii) of this section) and the Davis-Bacon poster (WH-1321) shall be posted at all times by the Contractor and its subcontractors at the site of the work in a prominent and accessible place where it can easily be seen by the workers.

(ii)(A) The contracting officer shall require that any class of laborers or mechanics, including helpers, which is not listed in the wage determination, and which is to be employed under the contract shall be classified in conformance with the wage determination. The contracting officer shall approve an additional classification and wage rate and fringe benefits therefore only when the following criteria have been met:

(1) The work to be performed by the classification requested is not performed by a classification in the wage determination;

(2) The classification is utilized in the area by the construction industry; and

(3) The proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination.

(B) If the Contractor and the laborers and mechanics to be employed in the classification (if known), or their representatives, and the contracting officer agree on the classification and wage rate (including the amount designated for fringe benefits where appropriate), a report of the action taken shall be sent by the contracting officer to the Administrator of the Wage and Hour Division, Employment Standards Administration, U.S. Department of Labor, Washington, DC 20210. The Administrator, or an authorized representative, will approve, modify, or disapprove every additional classification action within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

(C) In the event the Contractor, the laborers, or mechanics to be employed in the classification, or their representatives, and the contracting officer do not agree on the proposed classification and wage rate (including the amount designated for fringe benefits where appropriate), the contracting officer shall refer the questions, including the views of all interested parties and the recommendation of the contracting officer, to the Administrator for determination. The Administrator, or an authorized representative, will issue a determination within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

(D) The wage rate (including fringe benefits where appropriate) determined pursuant to subparagraphs (1)(ii) (B) or (C) of this paragraph, shall be paid to all workers performing work in the classification under this contract from the first day on which work is performed in the classification.

(iii) Whenever the minimum wage rate prescribed in the contract for a class of laborers or mechanics includes a fringe benefit which is not expressed as an hourly rate, the contractor shall either pay the benefit as stated in the wage determination or shall pay another bona fide fringe benefit or an hourly cash equivalent thereof.

(iv) If the Contractor does not make payments to a trustee or other third person, the Contractor may consider as part of the wages of any laborer or mechanic the amount of any costs reasonably anticipated in providing bona fide fringe benefits under a plan or program: *Provided* that the Secretary of Labor has found, upon the written request of the Contractor, that the applicable standards of the Davis-Bacon Act have been met. The Secretary of Labor may require the Contractor to set aside in a separate account, assets for the meeting of obligations under the plan or program.

2. Withholding.

The Federal Aviation Administration or the sponsor shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld from the Contractor under this contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to Davis-Bacon prevailing wage requirements, which is held by the same prime contractor, so much of the accrued payments or advances as may be considered necessary to pay laborers and mechanics, including apprentices, trainees, and helpers, employed by the Contractor or any subcontractor the full amount of wages required by the contract. In the event of failure to pay any laborer or

mechanic, including any apprentice, trainee, or helper, employed or working on the site of work, all or part of the wages required by the contract, the Federal Aviation Administration may, after written notice to the Contractor, Sponsor, Applicant, or Owner, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds until such violations have ceased.

3. Payrolls and Basic Records.

(i) Payrolls and basic records relating thereto shall be maintained by the Contractor during the course of the work and preserved for a period of three years thereafter for all laborers and mechanics working at the site of the work. Such records shall contain the name, address, and social security number of each such worker; his or her correct classification; hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalents thereof of the types described in 1(b)(2)(B) of the Davis-Bacon Act); daily and weekly number of hours worked; deductions made; and actual wages paid. Whenever the Secretary of Labor has found under 29 CFR 5.5(a)(1)(iv) that the wages of any laborer or mechanic include the amount of any costs reasonably anticipated in providing benefits under a plan or program described in section 1(b)(2)(B) of the Davis-Bacon Act, the Contractor shall maintain records that show that the commitment to provide such benefits is enforceable, that the plan or program is financially responsible, and that the plan or program has been communicated in writing to the laborers or mechanics affected, and that show the costs anticipated or the actual costs incurred in providing such benefits. Contractors employing apprentices or trainees under approved programs shall maintain written evidence of the registration of apprenticeship programs and certification of trainee programs, the registration of the apprentices and trainees, and the ratios and wage rates prescribed in the applicable programs.

(ii)(A) The Contractor shall submit weekly for each week in which any contract work is performed a copy of all payrolls to the Federal Aviation Administration if the agency is a party to the contract, but if the agency is not such a party, the Contractor will submit the payrolls to the applicant, Sponsor, or Owner, as the case may be, for transmission to the Federal Aviation Administration. The payrolls submitted shall set out accurately and completely all of the information required to be maintained under 29 CFR 5.5(a)(3)(i), except that full social security numbers and home addresses shall not be included on weekly transmittals. Instead, the payrolls shall only need to include an individually identifying number for each employee (*e.g.* the last four digits of the employee's social security number). The required weekly payroll information may be submitted in any form desired. Optional Form WH-347 is available for this purpose from the Wage and Hour Division Web site at www.dol.gov/whd/forms/wh347instr.htm or its successor site. The prime contractor is responsible for the submission of copies of payrolls by all subcontractors. Contractors and subcontractors shall maintain the full social security number and current address of each covered worker and shall provide them upon request to the Federal Aviation Administration if the agency is a party to the contract, but if the agency is not such a party, the Contractor will submit them to the applicant, sponsor, or Owner, as the case may be, for transmission to the Federal Aviation Administration, the Contractor, or the Wage and Hour Division of the Department of Labor for purposes of an investigation or audit of compliance with prevailing wage requirements. It is not a violation of this section for a prime contractor to require a subcontractor to provide addresses and social security numbers to the prime

contractor for its own records, without weekly submission to the sponsoring government agency (or the applicant, Sponsor, or Owner).

(B) Each payroll submitted shall be accompanied by a "Statement of Compliance," signed by the Contractor or subcontractor or his or her agent who pays or supervises the payment of the persons employed under the contract and shall certify the following:

(1) The payroll for the payroll period contains the information required to be provided under 29 CFR § 5.5(a)(3)(ii), the appropriate information is being maintained under 29 CFR § 5.5(a)(3)(i), and that such information is correct and complete;

(2) Each laborer and mechanic (including each helper, apprentice, and trainee) employed on the contract during the payroll period has been paid the full weekly wages earned, without rebate, either directly or indirectly, and that no deductions have been made either directly or indirectly from the full wages earned, other than permissible deductions as set forth in Regulations 29 CFR Part 3;

(3) Each laborer or mechanic has been paid not less than the applicable wage rates and fringe benefits or cash equivalents for the classification of work performed, as specified in the applicable wage determination incorporated into the contract.

(C) The weekly submission of a properly executed certification set forth on the reverse side of Optional Form WH-347 shall satisfy the requirement for submission of the "Statement of Compliance" required by paragraph (3)(ii)(B) of this section.

(D) The falsification of any of the above certifications may subject the Contractor or subcontractor to civil or criminal prosecution under Section 1001 of Title 18 and Section 231 of Title 31 of the United States Code.

(iii) The Contractor or subcontractor shall make the records required under paragraph (3)(i) of this section available for inspection, copying, or transcription by authorized representatives of the sponsor, the Federal Aviation Administration, or the Department of Labor and shall permit such representatives to interview employees during working hours on the job. If the Contractor or subcontractor fails to submit the required records or to make them available, the Federal agency may, after written notice to the Contractor, Sponsor, applicant, or Owner, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds. Furthermore, failure to submit the required records upon request or to make such records available may be grounds for debarment action pursuant to 29 CFR 5.12.

4. Apprentices and Trainees.

(i) Apprentices. Apprentices will be permitted to work at less than the predetermined rate for the work they performed when they are employed pursuant to and individually registered in a bona fide apprenticeship program registered with the U.S. Department of Labor, Employment and Training Administration, Bureau of Apprenticeship and Training, or with a State Apprenticeship Agency recognized by the Bureau, or if a person is employed in his or her first 90 days of probationary employment as an apprentice in such an apprenticeship program, who is not individually registered in the program, but who has been certified by the Bureau of Apprenticeship and Training or a State Apprenticeship Agency (where appropriate) to be eligible for probationary employment as an apprentice. The allowable ratio of apprentices to journeymen on the job site in any craft classification shall not be greater than the ratio permitted to the contractor as to the entire work force under the registered program. Any

worker listed on a payroll at an apprentice wage rate, who is not registered or otherwise employed as stated above, shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any apprentice performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed. Where a contractor is performing construction on a project in a locality other than that in which its program is registered, the ratios and wage rates (expressed in percentages of the journeyman's hourly rate) specified in the Contractor's or subcontractor's registered program shall be observed. Every apprentice must be paid at not less than the rate specified in the registered program for the apprentice's level of progress, expressed as a percentage of the journeymen hourly rate specified in the applicable wage determination. Apprentices shall be paid fringe benefits in accordance with the provisions of the apprenticeship program. If the apprenticeship program does not specify fringe benefits, apprentices must be paid the full amount of fringe benefits listed on the wage determination for the applicable classification. If the Administrator determines that a different practice prevails for the applicable apprentice classification, fringes shall be paid in accordance with that determination. In the event the Bureau of Apprenticeship and Training, or a State Apprenticeship Agency recognized by the Bureau, withdraws approval of an apprenticeship program, the Contractor will no longer be permitted to utilize apprentices at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

(ii) Trainees. Except as provided in 29 CFR 5.16, trainees will not be permitted to work at less than the predetermined rate for the work performed unless they are employed pursuant to and individually registered in a program which has received prior approval, evidenced by formal certification by the U.S. Department of Labor, Employment and Training Administration. The ratio of trainees to journeymen on the job site shall not be greater than permitted under the plan approved by the Employment and Training Administration. Every trainee must be paid at not less than the rate specified in the approved program for the trainee's level of progress, expressed as a percentage of the journeyman hourly rate specified in the applicable wage determination. Trainees shall be paid fringe benefits in accordance with the provisions of the trainee program. If the trainee program does not mention fringe benefits, trainees shall be paid the full amount of fringe benefits listed on the wage determination unless the Administrator of the Wage and Hour Division determines that there is an apprenticeship program associated with the corresponding journeyman wage rate on the wage determination that provides for less than full fringe benefits for apprentices. Any employee listed on the payroll at a trainee rate that is not registered and participating in a training plan approved by the Employment and Training Administration shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any trainee performing work on the job site in excess of the ratio permitted under the registered program shall be paid not less than the applicable wage rate on the wage determination for the work actually performed. In the event the Employment and Training Administration withdraws approval of a training program, the Contractor will no longer be permitted to utilize trainees at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

(iii) Equal Employment Opportunity. The utilization of apprentices, trainees, and journeymen under this part shall be in conformity with the equal employment opportunity requirements of Executive Order 11246, as amended, and 29 CFR Part 30.

5. Compliance with Copeland Act Requirements.

The Contractor shall comply with the requirements of 29 CFR Part 3, which are incorporated by reference in this contract.

6. Subcontracts.

The Contractor or subcontractor shall insert in any subcontracts the clauses contained in 29 CFR Part 5.5(a)(1) through (10) and such other clauses as the Federal Aviation Administration may by appropriate instructions require, and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime contractor shall be responsible for the compliance by any subcontractor or lower tier subcontractor with all the contract clauses in 29 CFR Part 5.5.

7. Contract Termination: Debarment.

A breach of the contract clauses in paragraph 1 through 10 of this section may be grounds for termination of the contract, and for debarment as a contractor and a subcontractor as provided in 29 CFR 5.12.

8. Compliance with Davis-Bacon and Related Act Requirements.

All rulings and interpretations of the Davis-Bacon and Related Acts contained in 29 CFR Parts 1, 3, and 5 are herein incorporated by reference in this contract.

9. Disputes Concerning Labor Standards.

Disputes arising out of the labor standards provisions of this contract shall not be subject to the general disputes clause of this contract. Such disputes shall be resolved in accordance with the procedures of the Department of Labor set forth in 29 CFR Parts 5, 6, and 7. Disputes within the meaning of this clause include disputes between the Contractor (or any of its subcontractors) and the contracting agency, the U.S. Department of Labor, or the employees or their representatives.

10. Certification of Eligibility.

(i) By entering into this contract, the Contractor certifies that neither it (nor he or she) nor any person or firm who has an interest in the Contractor's firm is a person or firm ineligible to be awarded Government contracts by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).

(ii) No part of this contract shall be subcontracted to any person or firm ineligible for award of a Government contract by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).

(iii) The penalty for making false statements is prescribed in the U.S. Criminal Code, 18 USC 1001.

CERTIFICATION OF OFFERER/BIDDER REGARDING DEBARMENT

By submitting a bid/proposal under this solicitation, the bidder or offeror certifies that neither it nor its principals are presently debarred or suspended by any Federal department or agency from participation in this transaction.

DISADVANTAGED BUSINESS ENTERPRISES

The Charles M. Schulz - Sonoma County Airport is committed to providing equal opportunity for the socially and economically disadvantaged, minorities, women, and small businesses participating in contracting opportunities. Below are business enterprise programs that support small, minority-, and women-owned businesses.

The Charles M. Schulz - Sonoma County Airport receives federal assistance from the U.S. Department of Transportation, and as a condition of receiving funding, Sonoma County Airport has established a Disadvantaged Business Enterprise (DBE) Program in accordance with 49 Code of Federal Regulations (CFR) Part 26.

Contract Assurance (§ 26.13) –

Schulz – Sonoma County Airport. The prime contractor agrees further to return retainage payments to each subcontractor within 15 days after the subcontractor's work is satisfactorily completed. Any delay or postponement of payment from the above referenced time frame may occur only for good cause following written approval of the Charles M. Schulz – Sonoma County Airport. This clause applies to both DBE and non-DBE subcontractors.

TEXTING WHEN DRIVING

In accordance with Executive Order 13513, "Federal Leadership on Reducing Text Messaging While Driving", (10/1/2009) and DOT Order 3902.10, "Text Messaging While Driving", (12/30/2009), the Federal Aviation Administration encourages recipients of Federal grant funds to adopt and enforce safety policies that decrease crashes by distracted drivers, including policies to ban text messaging while driving when performing work related to a grant or subgrant.

- (2) The Contractor will, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive considerations for employment without regard to race, color, religion, sex, or national origin.
- (3) The Contractor will send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the Contractor's commitments under this section and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

TRADE RESTRICTION CERTIFICATION

By submission of an offer, the Offeror certifies that with respect to this solicitation and any resultant contract, the Offeror –

- 1) is not owned or controlled by one or more citizens of a foreign country included in the list of countries that discriminate against U.S. firms as published by the Office of the United States Trade Representative (USTR);
- 2) has not knowingly entered into any contract or subcontract for this project with a person that is a citizen or national of a foreign country included on the list of countries that discriminate against U.S. firms as published by the USTR; and
- 3) has not entered into any subcontract for any product to be used on the Federal project that is produced in a foreign country included on the list of countries that discriminate against U.S. firms published by the USTR.

This certification concerns a matter within the jurisdiction of an agency of the United States of America and the making of a false, fictitious, or fraudulent certification may render the maker subject to prosecution under Title 18 USC Section 1001.

The Offeror/Contractor must provide immediate written notice to the Owner if the Offeror/Contractor learns that its certification or that of a subcontractor was erroneous when submitted or has become erroneous by reason of changed circumstances. The Contractor must require subcontractors provide immediate written notice to the Contractor if at any time it learns that its certification was erroneous by reason of changed circumstances.

Unless the restrictions of this clause are waived by the Secretary of Transportation in accordance with 49 CFR 30.17, no contract shall be awarded to an Offeror or subcontractor:

- 1) who is owned or controlled by one or more citizens or nationals of a foreign country included on the list of countries that discriminate against U.S. firms published by the USTR or
- 2) whose subcontractors are owned or controlled by one or more citizens or nationals of a foreign country on such USTR list or

- (2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.
- (3) The undersigned shall require that the language of this certification be included in the award documents for all sub-awards at all tiers (including subcontracts, subgrants, and

contracts under grants, loans, and cooperative agreements) and that all sub-recipients shall certify and disclose accordingly.

This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. OCCUPATIONAL SAFETY AND HEALTH ACT OF 1970

All contracts and subcontracts that result from this solicitation incorporate by reference the requirements of 29 CFR Part 1910 with the same force and effect as if given in full text. The term does not include separate or single-user rest rooms or necessary dressing or sleeping areas provided to assure privacy between the sexes.

PROCUREMENT OF RECOVERED MATERIALS

Contractor and subcontractor agree to comply with Section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act, and the regulatory provisions of 40 CFR Part 247. SEISMIC SAFETY

In the performance of design services, the Consultant agrees to furnish a building design and associated construction specification that conform to a building code standard that provides a level of seismic safety substantially equivalent to standards as established by the National Earthquake Hazards Reduction Program (NEHRP). Local building codes that model their building code after the current version of the International Building Code (IBC) meet the NEHRP equivalency level for seismic safety. At the conclusion of the design services, the Consultant agrees to furnish the Owner a “certification of compliance” that attests conformance of the building design and the construction specifications with the seismic standards of NEHRP or an equivalent building code.

CERTIFICATION OF OFFERER/BIDDER REGARDING TAX DELINQUENCY AND FELONY CONVICTIONS

The applicant must complete the following two certification statements. The applicant must indicate its current status as it relates to tax delinquency and felony conviction by inserting a checkmark (✓) in the space following the applicable response. The applicant agrees that, if awarded a contract resulting from this solicitation, it will incorporate this provision for certification in all lower tier subcontracts.

Certifications

Tax Delinquency: A tax delinquency is any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted, or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.

TERMINATION FOR CONVENIENCE (PROFESSIONAL SERVICES)

The Owner may, by written notice to the Consultant, terminate this Agreement for its convenience and without cause or default on the part of Consultant. Upon receipt of the notice of termination, except as explicitly directed by the Owner, the Contractor must immediately discontinue all services affected.

Upon termination of the Agreement, the Consultant must deliver to the Owner all data, surveys, models, drawings, specifications, reports, maps, photographs, estimates, summaries, and other documents and materials prepared by the Engineer under this contract, whether complete or partially complete.

Owner agrees to make just and equitable compensation to the Consultant for satisfactory work completed up through the date the Consultant receives the termination notice. Compensation will not include anticipated profit on non-performed services.

Owner further agrees to hold Consultant harmless for errors or omissions in documents that are incomplete as a result of the termination action under this clause.

TERMINATION FOR DEFAULT (PROFESSIONAL SERVICES)

Either party may terminate this Agreement for cause if the other party fails to fulfill its obligations that are essential to the completion of the work per the terms and conditions of the Agreement. The party initiating the termination action must allow the breaching party an opportunity to dispute or cure the breach.

The terminating party must provide the breaching party [7] days advance written notice of its intent to terminate the Agreement. The notice must specify the nature and extent of the breach, the conditions necessary to cure the breach, and the effective date of the termination action. The rights and remedies in this clause are in addition to any other rights and remedies provided by law or under this agreement.

- a) **Termination by Owner:** The Owner may terminate this Agreement in whole or in part, for the failure of the Consultant to:
1. Perform the services within the time specified in this contract or by Owner approved extension;
 2. Make adequate progress so as to endanger satisfactory performance of the Project; or
 3. Fulfill the obligations of the Agreement that are essential to the completion of the Project.

Upon receipt of the notice of termination, the Consultant must immediately discontinue all services affected unless the notice directs otherwise. Upon termination of the Agreement, the Consultant must deliver to the Owner all data, surveys, models, drawings, specifications, reports, maps, photographs, estimates, summaries, and other documents and materials prepared by the Engineer under this contract, whether complete or partially complete. Owner agrees to make just and equitable compensation to the Consultant for satisfactory work completed up through the date the Consultant receives the termination notice.

Compensation will not include anticipated profit on non-performed services.

Owner further agrees to hold Consultant harmless for errors or omissions in documents that are incomplete as a result of the termination action under this clause.

If, after finalization of the termination action, the Owner determines the Consultant was not in default of the Agreement, the rights and obligations of the parties shall be the same as if the Owner issued the termination for the convenience of the Owner.

- b) **Termination by Consultant:** The Consultant may terminate this Agreement in whole or in part, if the Owner:
1. Defaults on its obligations under this Agreement;
 2. Fails to make payment to the Consultant in accordance with the terms of this Agreement;
 3. Suspends the Project for more than [180] days due to reasons beyond the control of the Consultant.

Upon receipt of a notice of termination from the Consultant, Owner agrees to cooperate with Consultant for the purpose of terminating the agreement or portion thereof, by mutual consent. If Owner and Consultant cannot reach mutual agreement on the termination settlement, the Consultant may, without prejudice to any rights and remedies it may have, proceed with terminating all or parts of this Agreement based upon the Owner's breach of the contract.

In the event of termination due to Owner breach, the Engineer is entitled to invoice Owner and to receive full payment for all services performed or furnished in accordance with this Agreement and all justified reimbursable expenses incurred by the Consultant through the effective date of termination action. Owner agrees to hold Consultant harmless for errors or omissions in documents that are incomplete as a result of the termination action under this clause.

VETERAN'S PREFERENCE

In the employment of labor (excluding executive, administrative, and supervisory positions), the Contractor and all sub-tier contractors must give preference to covered veterans as defined

within Title 49 United States Code Section 47112. Covered veterans include Vietnam-era veterans, Persian Gulf veterans, Afghanistan-Iraq war veterans, disabled veterans, and small business concerns (as defined by 15 USC 632) owned and controlled by disabled veterans. This preference only applies when there are covered veterans readily available and qualified to perform the work to which the employment relates.

DOMESTIC PREFERENCE (per Addendum to MSA)

Consultant certifies by signing this Task Order that, to the greatest extent practicable, the Consultant has provided or will provide a preference for the purchase, acquisition, or use of goods, products, or materials produced in the United States (including, but not limited to, iron, aluminum, steel, cement, and other manufactured products) in compliance with 2 CFR § 200.322.”

EXHIBIT 2 to TASK ORDER

[.] Prevailing Wages

[.1] General. Consultant shall pay to persons performing _____ hereunder an amount equal to or more than the general prevailing rate of per diem wages for (1) work of a similar character in the locality in which the work is performed and (2) legal holiday and overtime work in said locality. The per diem wages shall be an amount equal to or more than the stipulated rates contained in a schedule that has been ascertained and determined by the Director of the State Department of Industrial Relations and County to be the general prevailing rate of per diem wages for each craft or type of workman or mechanic needed to execute this Agreement. Consultant shall also cause a copy of this determination of the prevailing rate of per diem wages to be posted at each site work is being performed. Copies of the prevailing wage rate of per diem wages are on file at the _____ [County Department] and will be made available to any person upon request.

[.2] Subcontracts. Consultant shall insert in every subcontract or other arrangement which Consultant may make for performance of such work or labor on work provided for in the Agreement, provision that Subcontractor shall pay persons performing labor or rendering service under subcontract or other arrangement not less than the general prevailing rate of per diem wages for work of a similar character in the locality in which the work is performed, and not less than the general prevailing rate of per diem wages for holiday and overtime work fixed in the Labor Code. Pursuant to Labor Code Section 1775(b)(1), Consultant shall provide to each Subcontractor a copy of Sections 1771, 1775, 1776, 1777.5, 1813 and 1815 of the Labor Code.

[.3] Compliance Monitoring and Registration: This work specified above is subject to compliance monitoring and enforcement by the Department of Industrial Relations. Consultant shall furnish and shall require all subcontractors to furnish the records specified in Labor Code section 1776 (e.g. electronic certified payroll records) directly to the Labor Commissioner in a format prescribed by the Labor Commissioner at least monthly (Labor Code 1771.4 (a)(3)). Consultant and all subcontractors performing work that requires payment of prevailing wages shall be registered and qualified to perform public work pursuant to Labor Code section 1725.5 as a condition to engage in the performance of any services under this Agreement.

[.4] Compliance With Law. In addition to the above, Consultant stipulates that it shall comply with all applicable wage and hour laws, including without limitation Labor Code Sections 1725.5, 1775, 1776, 1777.5 1813 and 1815 and California Code of Regulations, Title 8, Section 16000, et seq.

PROJECT OVERVIEW DESCRIPTION

This Scope of Services details the Engineer-of-Record (EOR) responsibilities to be provided by Mead & Hunt, Inc. (CONSULTANT) during Construction Phase 2 of the STS Terminal Apron Reconstruction (Project) at the Charles M. Schulz – Sonoma County Airport (Airport) for the County of Sonoma (COUNTY).

Construction Observation (CO) Firm - C&S Companies (Contracted with COUNTY)

COUNTY has contracted with C&S Companies to provide daily construction observation and monitoring for the Project. C&S will also be responsible for coordinating with the company that will be performing Quality Assurance (QA) Testing, which will be contracted directly with the COUNTY.

The COUNTY has identified the Construction Manager at Risk (CMAR) delivery method as the preferred approach for ensuring functional phasing, cost stabilization, low operational impacts, and success of the Project. The Construction Manager (CM) team that was selected is Granite Construction, who will provide construction services for the Project.

Background and Project Elements

The Airport is public use owned and operated by the COUNTY. It is located approximately 7 miles northwest of downtown Santa Rosa, California. The Airport has two runways with the following respective Runway Design Codes: Runway 14-32, D-III; and Runway 2-20, C-III. The Airport serves privately operated general aviation, executive and business aircraft, and also provides commercial air service operated by Alaska Airlines, American Airlines, and Avelo Airlines.

The Terminal Apron was originally constructed with asphalt concrete in 1967 and expanded to the west in 1979. Based on the available information, no improvements were performed on the apron until the reconstruction of the southern part of the Terminal Apron (existing parking positions 3 and 4) with concrete pavement in 2015. Concrete pads were constructed in 2019 on parking positions 1 and 2 to limit the pavement failures developing in those areas. The STS Terminal Apron Reconstruction, Phase 1A project is currently in the pre-construction phase and consists of storm drainage improvements including a treatment system for stormwater.

The overall Project scope consists of the following elements: existing asphalt concrete pavement reconstruction; new Portland cement concrete pavement construction; and electrical improvements consisting of Ground Power Unit (GPU), Ground Service Equipment (GSE), and apron lighting infrastructure.

Funding for the remaining Project construction is anticipated to be by Federal Aviation Administration (FAA) Airport Infrastructure Grant (AIG), Airport Improvement Program (AIP) Grant, and COUNTY funds. Due to availability of funding, the Project has been divided into multiple construction phases. The Phase 2 construction work to be performed under this contract includes the following:

- Demo of existing Asphalt Concrete (AC) paving.
- Demo of existing Portland Cement Concrete (PCC) pavement.
- Removal of existing PCC Tie-Down Anchors and Fencing & Gate.
- AC Paving.
- PCC pavement construction.
- Installation of Electrical GPU.
- Installation of Electrical GSE.
- Installation of Apron Lightning Infrastructure.

Project Duration

Construction Phase 2 has been divided into two Elements: 1) Mobilization and 2) Construction. The COUNTY will issue separate NTPs to the CM for each Element. The NTP for the Construction Element will not be issued until the Mobilization Element is complete and the CM-provided Safety Plan Compliance Document (SPCD) is approved by the COUNTY. The anticipated Project duration is shown in the following table:

The Construction Safety and Phasing Plan (CSPP) is included in the Project Specifications and contains additional details on the time limitations, as well as specific phasing requirements for the Project.

Project Team

The following identifies Mead & Hunt staff and their responsibilities:

- 1) Senior Associate (SA) – Contracting, general Project coordination.
- 2) Project Engineer / Project Manager (PM) – Engineer of Record, project management, general Project coordination, CO coordination, quality control, attend coordination meetings, regular site visits to review construction activities, monitor continuity throughout the Project duration.
- 3) Senior Engineer (SE) – Assist with Project management, assist with general Project coordination, assist with Field Representative (FR) coordination, quality control, attend coordination meetings, and conduct periodic site visits to review construction activities.
- 4) Field Representative (FR) – The FR will be the CONSULTANT's lead point of contact through the Project and will monitor construction and quality control. FR will attend weekly construction coordination meetings, coordinate with CO for material QA testing, assist with RFIs, perform periodic construction observation and reporting, and monitor conformance with Project Plans and Specifications.
- 5) Engineer III – This person will provide office support and review submittals, Requests for Information (RFI), Requests for Cost Proposal (RFCP), Field Directives, Contract Change Orders, Pay Applications, and other construction documentation.
- 6) Engineer I – Will provide office support assisting the PM and Engineer III with documents as well as AutoCAD exhibits.

- 7) Technician IV –Office CAD support for RFIs, Exhibits, and Contract Change Orders.
- 8) Administrative Assistant – Project invoicing, document editing, proofing, and formatting.

Scope Elements

This scope of services is defined in the following tasks:

- Task 1 Pre-Construction Services
- Task 2 Construction Engineer of Record Services
- Task 3 Construction Observation – Not in Contract (NIC)
(to be provided by COUNTY-contracted Construction Observation firm)
- Task 4 Material Testing – NIC
(to be provided by COUNTY-contracted Material Testing firm)
- Task 5 Post-Construction Services

SCOPE OF SERVICES

The CONSULTANT will assign a Project Manager (PM) to this Project. The PM will be responsible for the overall administration of CONSULTANT'S work. Specific Project management tasks are detailed within each task of this scope of work. The CONSULTANT team will also consist of civil engineers, designers, and administrative staff as needed to perform the tasks in this scope of work.

TASK 1 PRE-CONSTRUCTION SERVICES

1.1 PROJECT MANAGEMENT AND COORDINATION

Project management tasks during Task 1 of this scope will consist of the following:

- 1.1.1 Prepare Contract and Project Setup
The PM and administrative staff will prepare the contract between the CONSULTANT and the COUNTY. Administrative staff will also set up the internal Project database for finance tracking, and internal Project directory for saving files.
- 1.1.2 Coordinate CONSULTANT Team
The PM will assign team members to the Project for office Construction Administration activities and periodic field observation activities. The PM will coordinate with team members to plan for construction activities and identify additional team members if needed for support.
- 1.1.3 Prepare Invoices
The PM will maintain a Project budget spreadsheet to track monthly costs. At the beginning of each month, the PM will review accrued costs from the previous month and work with CONSULTANT's accounting staff to prepare Project invoices for the COUNTY. The invoices will be submitted in accordance with the COUNTY's standard invoice requirements. The invoices will include detailed cost breakdowns referencing the items in this scope of work and indicate the percent complete for each item. It is anticipated that one (1) invoice will be prepared during Task 1 of CONSULTANT'S services.

1.2 PROJECT MEETINGS AND COMMUNICATION

1.2.1 Phase 2 Pre-Construction Meeting

It is anticipated there will be a pre-construction meeting for Phase 2 of construction. CONSULTANT will attend the pre-construction conference. It is anticipated that the meeting will be conducted at the Airport and facilitated by CO and / or COUNTY. The PM and FR will attend.

1.2.2 Quality Control (QC) / Quality Assurance (QA) Workshop

The CONSULTANT will attend a QC/QA workshop in accordance with Project Specification Item C-100. The QC/QA workshop will be coordinated and facilitated by the CO and / or COUNTY. Up to two (2) members from the CONSULTANT team will attend (anticipated to consist of PM and FR).

1.2.3 Bi-Weekly Internal Project Status Meeting

The PM will prepare for and conduct bi-weekly meetings (duration - thirty (30) minutes), with the internal CONSULTANT team to discuss the Project schedule and work progress. Up to three (3) members from CONSULTANT Team will attend each meeting (anticipated to consist of SA, SE, and PM). Up to two (2) meetings are anticipated during Task 1.

1.2.4 Bi-Weekly Project Status Meeting with COUNTY

The CONSULTANT will prepare for and conduct bi-weekly meetings (duration - up to one (1) hour) with the COUNTY to discuss the Project schedule, work progress, and coordination items. Up to three (3) members from CONSULTANT Team will attend each meeting (anticipated to consist of SA, SE and PM). Up to two (2) meetings are anticipated during Task 1. The meetings are anticipated to be held virtually.

1.2.5 Additional Phasing Coordination for Phase 2 Construction

Due to the complexity and evolving Project Phasing plan, it is anticipated that additional efforts will be required of CONSULTANT for coordination with the COUNTY, CO, and CM for phasing efforts related to Phase 2 Construction. CONSULTANT will plan to attend two (2) additional meetings (anticipated to consist of SA, PM, SE and FR), coordinate with internal Project team, and issue associated Exhibits. The meetings are anticipated to be held virtually.

1.2.6 General Communication with COUNTY and CO

The CONSULTANT will communicate with the COUNTY, CO, and CM throughout work efforts in Task 1 of this scope as needed via phone, email, or on-site visits, in addition to the meetings listed herein.

1.3 GUARANTEED MAXIMUM PRICE (GMP) COORDINATION

The CONSULTANT will assist the CO in reviewing the Phase 2 cost estimate provided by the CM and support the process for negotiating a Phase 2 GMP. This effort will include reviewing the engineer's estimate prepared by the CONSULTANT in comparison with the CM estimate, as well as verification of phasing quantities estimated by CM.

1.4 PREPARE PROJECT DOCUMENTATION

The CONSULTANT will assemble and provide the CM with CAD files if requested, upon receipt of CM's authorized signature on the CONSULTANT-provided disclaimer form.

1.5 PREPARE PHASE 2 PLANS FOR CONSTRUCTION

The CONSULTANT will prepare 'issued-for-construction' plan sheets related to Phase 2. The plan sheets will be based on the construction set prepared during Phase 1A construction but will also incorporate elements determined as a result of phasing coordination, such as temporary tie-in conditions due to unknown date of completion of the remaining construction phases. Significant changes to the plan set beyond the items described herein will not be included. The plans will be stamped and signed by the Engineer-of-Record responsible for stamping the construction set.

1.6 CONSTRUCTION MANAGEMENT PLAN (CMP) - NIC

CO is responsible for preparation of a CMP.

TASK 1 DELIVERABLES

- 1) Additional Phasing Coordination Exhibit(s) – electronic to CM, CO, and COUNTY
- 2) Phase 2 Plans for Construction – electronic file to CM, CO, and COUNTY

TASK 2 CONSTRUCTION ENGINEER OF RECORD (EOR) SERVICES

2.1 PROJECT MANAGEMENT AND COORDINATION

Project management tasks during Task 2 will consist of the following:

2.1.1 Coordinate CONSULTANT Team

The PM will assign responsibilities to office staff to complete the documentation efforts described herein.

2.1.2 Prepare Invoices

The PM will maintain the Project budget spreadsheet and files and prepare invoices as defined in Task 1. It is anticipated that a total of five (5) invoices will be prepared during Task 2 work.

2.2 REVIEW MATERIAL SUBMITTALS FOR COMPLIANCE

The CONSULTANT will review CM-submitted material cut sheets, mix designs, shop drawings, and certificates for compliance with Project plans and specifications, and coordinate responses to the CM with the CO. It is expected that up to ten (10) submittals will be provided by the CM for review. Additional submittals may be required for the latter construction phases, which will be covered under a separate proposal if required. The scope assumes each submittal will require up to one (1) resubmittal due to incomplete or incorrect information by the CM. If more than one (1) resubmittal is required due to incomplete or incorrect information by the CM, the cost for the CONSULTANT to review the resubmittal will be the responsibility of the CM as stated in Specification Item SP-100. The CONSULTANT will also maintain a submittal checklist, and track dates of submission and review.

2.3 PROJECT MEETINGS AND COMMUNICATION

The CONSULTANT will participate in various meetings and calls during the Project. Meetings and communication items will be as follows:

2.3.1 Weekly Construction Progress Meetings

The CONSULTANT will attend weekly meetings with the COUNTY, CO, FAA, and CM to discuss safety, schedule, work progress, action items, documentation, and other items as needed to keep construction on track. Up to fourteen (14), one (1) hour, in person meetings are anticipated. The meetings are anticipated to be at a location near the job site. The PM and the FR will attend each meeting, either in-person or virtually as appropriate for the work being performed that week.

2.3.2 Site Visits During Construction

The CONSULTANT will conduct periodic site visits to review Project progress and monitor construction activities through substantial completion of Construction. Up to fourteen (14) site visits are anticipated. It is anticipated the following members from the CONSULTANT team will attend the site visits: FR (14 site visits), PM (4 site visits), Engineer III (4 site visits), and Engineer I (4 site visits).

2.3.3 Bi-Weekly Internal Project Status Meeting

The PM will conduct bi-weekly meetings, up to thirty (30) minutes, with the internal CONSULTANT team to discuss the Project schedule and work progress. Up to three (3) members from CONSULTANT Team will attend each meeting (anticipated to consist of SA, SE, and PM)). Up to seven (7) meetings are anticipated during Task 2.

2.3.4 Bi-Weekly Project Status Meeting with COUNTY

The CONSULTANT will conduct bi-weekly meetings (duration - up to one (1) hour) with the COUNTY to discuss the Project schedule, work progress, and coordination items. Up to three (3) members from CONSULTANT Team will attend each meeting (anticipated to consist of SA, SE, and PM). Up to seven (7) meetings are anticipated during Task 2. The meetings are anticipated to be held virtually.

2.3.5 Additional Phasing Coordination for Phases following Phase 2 Construction

Due to the complexity and evolving Project Phasing plan, it is anticipated that additional efforts will be required of CONSULTANT for coordination with the COUNTY, CO, and CM for phasing efforts related to subsequent phases following Phase 2 construction. Based on the original construction set, two additional phases are anticipated after Phase 2 construction. CONSULTANT will plan to attend two (2) additional meetings (anticipated to consist of SA, PM, SE and FR), coordinate with internal Project team, and issue associated Exhibits. The meetings are anticipated to be held in-person at the Airport conference room.

2.3.6 General Communication with COUNTY and CO

The CONSULTANT will communicate with the COUNTY and CO throughout Construction of the Project. Four (4) hours are allocated for the PM and two (2) hours for the SE per week.

2.4 REQUESTS FOR INFORMATION (RFIs)

The CONSULTANT will prepare written responses to RFIs, as necessary, to clarify design intent. Up to twelve (12) RFIs are anticipated for Phase 2. If required, revised design documents at the request of the CM or the CO that are beyond the design scope, will be considered Additional Services.

2.5 GENERAL FIELD COORDINATION

In addition to formal RFIs, the CONSULTANT will respond to various questions and concerns that arise in the field. Depending on the issue, the response may require review of documentation not included in the Contract Documents, as well as coordination with and review by additional CONSULTANT staff, COUNTY, or FAA.

2.6 REQUESTS FOR COST PROPOSALS (RFCPs)

The CONSULTANT will assist the CO firm in preparing RFCPs if additional work is needed, due to unforeseen site conditions, or if value engineering is applied. COUNTY's request for additional work will be considered additional services as applicable. The RFCP(s) will be based on direction by the COUNTY with input from the CO and will include a description of the change, quantity estimates, and exhibits as needed to illustrate the changes. This proposal assumes that the CO will send the RFCP to the CM to provide a cost proposal and then review the cost proposal to determine if it is reasonable and follow up with negotiations, as necessary. The CO will perform cost analysis of the work, separate from the CONSULTANT, to be used as an Independent Fee Estimate (IFE). It is also assumed that the CO will communicate the proposed change and cost to the FAA for their concurrence prior to authorizing the work. It is assumed that, depending on the determination, the CONSULTANT will prepare field directives and change orders. CONSULTANT's assistance with up to five (5) RFCPs is included in this scope.

2.7 FIELD DIRECTIVES

The CONSULTANT will assist the CO, as requested by the COUNTY, in preparing field directives necessary to formalize direction that is not otherwise stated in the Project plans or specifications, or in a response to an RFI or value engineering. Following the RFCP process above, it is assumed that the CO will prepare a field directive authorizing the CM to proceed with work as described. This scope has allocated up to five (5) field directives requiring the CONSULTANT's participation.

2.8 CONTRACT CHANGE ORDERS (CCOs)

Following the RFCP and field directive processes, the CONSULTANT will support the CO in the preparation of CCOs to formalize the change to the Contract cost. The CONSULTANT will review the CCO documents provided by the CO firm. The CO will be responsible for submitting the CCOs to the COUNTY and CM for review and signature and then to the FAA. This scope allows for CONSULTANT's assistance with two (2) CCOs.

2.9 REVIEW OF QUALITY CONTROL (QC) AND QUALITY ASSURANCE (QA) TEST RESULTS

The CONSULTANT will review CM-provided QC and COUNTY-provided QA test results for concurrence with the intent of the plans and specifications. Any corrective action required by failing test results will be addressed by the CO and reviewed by the CONSULTANT. Depending on the

nature of the testing, the CM and COUNTY may need to coordinate with the FAA to determine appropriate actions.

2.10 MONTHLY APPLICATIONS FOR PAYMENT

CONSULTANT to review CO-prepared CM pay applications and report to the COUNTY on the impact to the Project of budget remaining vs. work to be completed. Up to five (5) applications for payment are anticipated for the Project.

2.11 SUBSTANTIAL COMPLETION WALK-THROUGH AND DOCUMENTATION

The CONSULTANT (PM and SE) will attend a walk-through with the CO, COUNTY, and the CM to determine whether Phase 2 has reached substantial completion and review the work for general accordance with the Plans and Specifications. The CONSULTANT will document items found to be deficient, develop a Punchlist, and will provide the CO with a list of those items. It is assumed that the CO and COUNTY will observe the completed Project.

TASK 2 DELIVERABLES

- 1) Additional Phasing Coordination Exhibit(s) – electronic to CM, CO, and COUNTY
- 2) RFI Review Comments – electronic files to the CO and COUNTY
- 3) RFCP Review Comments – electronic files to the CO and COUNTY
- 4) Field Directive Review Comments – electronic files to the CO and COUNTY
- 5) CCO Review Comments – electronic files to the CO and COUNTY
- 6) Monthly Applications for Payment Review Comments – electronic files to the COUNTY
- 7) Punch List and Substantial Completion Letter – electronic files to COUNTY and CM

(to be provided by COUNTY-hired Construction Observation firm)

TASK 4 MATERIAL TESTING – NIC

(to be provided by COUNTY-hired Material Testing firm)

TASK 5 POST-CONSTRUCTION SERVICES

5.1 PROJECT MANAGEMENT

5.1.1 Coordinate CONSULTANT Team

The PM will assign responsibilities to office staff to complete the documentation efforts described herein. The PM will also coordinate with the CO for providing field data to complete the documentation efforts described herein.

5.1.2 Prepare Invoices

The PM will continue to maintain the Project budget spreadsheet and prepare invoices as defined in Task 1. It is anticipated that two (2) invoices will be prepared during Task 5.

5.2 COMMUNICATION

The CONSULTANT will communicate with the COUNTY, CM, and CO throughout post-construction, as needed via phone calls or email. Eight (8) hours have been allocated for the SA, SE, and PM each.

5.3 RECORD DRAWINGS

The CONSULTANT, CO, and CM will coordinate throughout construction to document field constructed conditions, and markup the Construction Plans. Upon completion of construction, the CONSULTANT will prepare the Record Drawings using AutoCAD Civil 3D, by updating the drawing files created during design. The Drawings will become record information. The CONSULTANT will provide the COUNTY with a set of reproducible Record Drawings in digital format.

5.4 FINAL CONSTRUCTION REPORT (FCR)

CONSULTANT will provide CO with field notes taken from site visits, along with relevant COUNTY correspondence if requested, to assist with the FCR preparation, which will be prepared by the CO.

PHASE 5 DELIVERABLES

- 1) Record Drawings – electronic files to the COUNTY
- 2) Supporting documentation of field observations for inclusion in the Final Construction Report. – electronic files to the CO.

SCHEDULE OF COMPLETION

The CONSULTANT will complete the work called for in Task 1 and Task 2 of this scope of services on a schedule submitted by the CM and approved by the COUNTY.

The CONSULTANT will complete the work called for under Task 5 within forty-five (45) working days of the receipt of record drawing markups from the CM. *(Note: Tasks 3 and 4 are not included in this scope.)*

SERVICES TO BE PROVIDED BY THE COUNTY AND EXCLUDED SERVICES

The COUNTY and CONSULTANT agree that the following items will be provided by the COUNTY or excluded from this scope, and if added to the CONSULTANT's work will be considered extra services and a negotiated fee will be established, and an Amendment prepared:

- 1) Issuing of Notices to Airmen (NOTAMs) and announcements regarding the impact of the Project on aviation activities.
- 2) Guaranteed access and provisions for the CONSULTANT to enter the Airport as required to perform work under this Agreement.
- 3) Examination of documents requested by the COUNTY and presented by the CONSULTANT, and render (in writing) decisions pertaining thereto within a reasonable time so as not to delay the work of the CONSULTANT.
- 4) Contract change orders that require new design elements beyond the scope of the awarded contract.
- 5) Extensions of construction time beyond the awarded contract timeframes.
- 6) Construction administration and observation services will be performed by the CO.

- 7) FAA grant reimbursement submission.
- 8) Filing of Notice of Completion to the FAA.
- 9) Airport Layout Plan updates.
- 10) Updates to Airfield Pavement Management System (APMS).
- 11) Updates to Airfield Signage and Marking Plan.
- 12) Required permits will be managed and administered by COUNTY or other parties unless specifically identified in CONSULTANT scope of work.

COMPENSATION FOR SERVICES

The **total** amount for CONSULTANT's services described in this Scope of Services is **One Hundred Seventy-Five Thousand Seven Hundred Forty-Five Dollars (\$175,745.00)**. Payment for work outlined in this Scope of Services shall be on a time-and-expense basis. This fee includes labor, materials, expenses, and incidentals necessary to complete the work as described herein. Payments to be made monthly based on hours and expenses incurred by the Consultant in conformance with the Mead & Hunt, Inc. Standard Billing Rate Schedule, effective January 1, 2025, included as *Attachment 2*.

These amounts shall not be exceeded without written authorization from the COUNTY. The Engineer's fee estimate / breakdown is included as *Attachment 1*.

Payment for any additional services requested by the COUNTY will be performed on a time-and-expense basis in conformance with the Mead & Hunt, Inc. Standard Billing Rate Schedule, effective January 1, 2025, included as *Attachment 2*. The CONSULTANT will establish the budget for additional services prior to the start of work and may not exceed the budget without written authorization from the COUNTY. Any additional services must be authorized in writing by the COUNTY.
