SUBJECT: Selection of Brown & Caldwell for Phase 2 Engineering Study for North Bay

Water Reuse Authority

Sonoma County Water Agency (Sonoma Water), as approved by its Board of Directors, entered into a Memorandum of Understanding (MOU) with other North Bay entities to establish the North Bay Water Reuse Authority (Authority). The purpose of the Authority is to expand the beneficial use of recycled water in the North Bay region under the North Bay Water Reuse Program (Program), thereby promoting the conservation of limited surface water and groundwater resources. Sonoma Water is the Administrative Agency for the Authority. In this capacity, Sonoma Water awards, executes in its own name, and administers such contracts on behalf of the Authority as authorized by the Authority's Board of Directors.

Under the subject agreement, Brown & Caldwell will 1) provide recycled water support services to Authority member agencies; 2) review and assess Sonoma Water's Regional Water Supply Resiliency Study (Study) to determine if the Study meets the criteria of a U.S. Bureau of Reclamation (Reclamation) Drought Contingency Plan, identify actions needed to meet criteria, and allow Authority member agencies to make revisions or enhancements to the Study to afford them the opportunity to apply for Reclamation funding under the Drought Resiliency Program; and 3) develop a Sea Level Rise Adaptation Vision that can be articulated to stakeholders and provides a framework for participating agencies in the area to identify and implement individual projects in the context of a common vision.

Brown & Caldwell was selected from a list of qualified consultants developed from a competitive selection process. Attached is a memo that explains the competitive selection process.

Brown & Caldwell was selected for the subject work because of its experience with similar types of projects and demonstrated understanding of Authority's needs.
