

**THIRD AMENDMENT TO
PROFESSIONAL SERVICES AGREEMENT**

This Third Amendment ("Amendment"), dated as of November 14, 2024, ("Effective Date") is by and between the County of Sonoma, a political subdivision of the State of California (hereinafter "County"), and InterFaith Shelter Network, Inc., a nonprofit public-benefit corporation 501(c)(3) authorized to do business in the State of California (hereinafter "Contractor").

RECITALS

WHEREAS, County and Contractor entered into that certain Agreement, dated December 1, 2019, to provide supportive housing and case management services for justice system-involved individuals; and

WHEREAS, County and Contractor desire to amend the Agreement to extend the term, increase the not-to-exceed amount, and modify the scope of work and fee schedule.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

AGREEMENT

1. County and Contractor agree to amend the not-to-exceed amount in the Second Amendment will increase from \$2,100,000 to \$2,235,000; and
2. Except to the extent the Agreement is specifically amended or supplemented hereby, the Agreement, together with exhibits is, and shall continue to be, in full force and effect as originally executed, and nothing contained herein shall, or shall be construed to modify, invalidate, or otherwise affect any provision of the Agreement or any right of County arising thereunder.
3. This Amendment shall be governed by and construed under the internal laws of the state of California, and any action to enforce the terms of this Amendment or for the breach thereof shall be brought and tried in the County of Sonoma.

COUNTY AND CONSULTANT HAVE CAREFULLY READ AND REVIEWED THIS AMENDMENT AND EACH TERM AND PROVISION CONTAINED HEREIN AND, BY EXECUTION OF THIS AMENDMENT, SHOW THEIR INFORMED AND VOLUNTARY CONSENT THERETO.
