## **ORDINANCE NO. ()**

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SONOMA, STATE OF CALIFORNIA, AMENDING ORDINANCE NO. 2300 TO ESTABLISH NO PARKING ZONE RESTRICTIONS ON SHAW AVENUE (#76014) AND MAPLE AVENUE (#76013); ESTABLISHING A MIDBLOCK CROSSWALK ON SHAW AVENUE BETWEEN 60 AND 75 SHAW AVENUE (POSTMILE 10.755); AND AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF PUBLIC INFRASTRUCTURE TO ACCEPT CROSSING IMPROVEMENTS TO BE INSTALLED BY VJB VINEYARD AND CELLARS INTO THE COUNTY'S ROAD MAINTENANCE INVENTORY

The Board of Supervisors of the County of Sonoma, State of California, ordains as follows:

**Section I.** Subsection 572 is hereby added to Section VII of Sonoma County Ordinance No 2300 (said Section establishes No Parking zones) to read:

West side of Shaw Avenue (#76014) from Postmile 10.11 to 10.20 and the east side of Shaw Avenue from Postmile 10.19 to 10.20.

**Section II.** Subsection 573 is hereby added to Section VII of Sonoma County Ordinance No 2300 (said Section establishes No Parking zones) to read:

West side of Maple Avenue (#76013) from Postmile 10.14 to 10.21.

**Section III.** A midblock crosswalk is hereby established on Shaw Avenue (#76014) between 60 and 75 Shaw Avenue (Postmile 10.755) pursuant to Vehicle Code Section 21106.

**Section IV.** The Director of Sonoma Public Infrastructure is authorized to accept crossing improvements to be installed for the midblock crosswalk into the County Road Maintenance Inventory.

**Section V.** If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of this Ordinance. The Board of Supervisors hereby declares that it would have passed this Ordinance and every section, subsection, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional or invalid.

**Section VI.** This Ordinance shall be and the same is hereby declared to be in full force and effect from and after thirty (30) days after the date of its passage and shall be published once before the expiration of fifteen (15) days after said passage, with the names of the Supervisors voting for or against the same, in *The Press Democrat*, a newspaper of general circulation published in the County of Sonoma, State of California.
