Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,

Authorizing The Redesignation Of \$2.8 Million In Measure O Emergency Psychiatric/Crisis

Services (Category #3) To Measure O Transitional & Permanent Supportive Housing (Category #5)

Whereas, the Board of Supervisors has adopted the final budget for fiscal year 2023-2024 in accordance with Section 29088 of the Government Code of the State of California; and

Whereas, on April 5, 2022, the Board authorized the Community Development Commission to acquire real property at 18100 Highway 116, Guerneville, CA, known as George's Hideaway; and

Whereas, on August 15, 2023, the Board adopted a resolution authorizing the redesignation of \$2.8 million in Measure O (Category #4-Bhavioral Health Homeless and Care Coordination) to Measure O (Category #5-Transitional and Permanent Supportive Housing, and the Board authorized the Director of Health Services to execute fiscal year 2023-2024 Measure O Transitional and Permanent Supportive Housing contracts including support of the Community Development Commission's project at George's Hideaway; and

**Whereas,** the Community Development Commission has a determined funding short-fall for George's Hideaway project, the need for additional transference is required to complete this project; and

**Whereas,** there is a need to move Measure O fund balance to cover aforementioned shortfall and appropriate funds to pay Community Development Commission for both Reimbursements and expenditures; and

**Whereas**, there is a need to appropriate funds in Measure O Operations to move to Homelessness Services to fund the Community Development Commission's George's Hideaway project;

Now, Therefore, Be It Resolved that the Board of Supervisors, County of Sonoma, State
