On behalf of the Sonoma County Board of Supervisors, we respectfully request that you support the passage of two bills already passed in the House of Representatives:

- H.R. 1603 Farm Workforce Modernization Act
- H.R. 6 American Dream and Promise Act of 2021

The Farm Workforce Modernization Act of 2021 would provide more robust protections for our nation's nonimmigrant farmworkers workforce. This bill would provide temporary protections through a designation as a "Certified Agricultural Worker" (CAW) while also giving nonimmigrant workers the opportunity to apply for legal permanent resident status after ten years of agricultural work. Furthermore, this bill would create an E-Verify system through the Department of Homeland Security for agricultural employment authorization. Finally, this bill would also create a Housing Preservation and Revitalization Program, to provide financial rental assistance to qualified individuals. We believe that the passage of H.R. 1603 would be a boon to Sonoma County as these nonimmigrant farmworkers contribute so much to our local economy.

The American Dream and Promise Act of 2021 would allow "Dreamers," U.S.-raised immigrant youth, to receive lawful permanent residence status and American citizenship. This bill also includes provisions providing pathways to citizenship for other nonimmigrant residents with temporary protected status as well. The passage of H.R. 6 would provide security to present "Dreamers" afraid of deportation across the nation, while also contributing to the wellbeing of nonimmigrant residents living in Sonoma County. We owe our support to these individuals as they contribute so much to our local and national livelihoods.

While the House has passed both these bills, we understand there is a possibility – which we would also support – that they may be included in the Reconciliation measure being drafted by the Senate Judiciary Committee.
