SUBJECT: **LIST OF QUALIFIED CONSULTANTS FOR CRANE AND HOIST INSPECTION

FUNDED PROJECTS**

Cal-OSHA mandates hoist and crane inspection and certification. Sonoma County Water Agency requires the services of a consultant for performing annual certifications, quarterly inspections, and inspections on various Sonoma County Water Agency hoists and cranes. Work includes preparing inspection reports, performing safety training, and completing inspections as required by Cal-OSHA standards.

On July 6, 2020, Sonoma County Water Agency (Sonoma Water) issued a Request for Statements of Qualifications (RFQ) to the following five firms:

- Allied Crane, Inc., Pittsburgh, CA
- Carpenter Crane Hoist, Vacaville, CA
- Crane & Equipment Regulatory & Training Services, LLC, Santa Rosa, CA
- Industrial Crane Repair, Sacramento, CA
- Konecranes USA, Sacramento, CA

The RFQ was also posted on the Sonoma County Water Agency and County of Sonoma Purchasing Department websites.

The two firms listed below submitted Statements of Qualifications (SOQs):

- Crane Certification and Training, Inc., Boulder Creek, CA
- GP Crane & Hoist Services, Napa, CA

The following criteria were used to evaluate each firm:

- Thoroughness of SOQ
- Professional qualifications and demonstrated ability to perform the work
- Exceptions to standard terms in the sample agreement
- Local Service Provider Preference

Based on the evaluations, the following respondents were selected for the list of qualified consultants:
