Concurrent Resolution Of The Board Of Directors Of The Sonoma County Water Agency And Its Associated Sanitation Districts (Occidental, Russian River, South Park, And Sonoma Valley County Sanitation Districts) (Districts), Delegating Authority To The General Manager Of Sonoma County Water Agency, Or A Qualified Designated Employee Representative, To Implement The Procedures For Summary Vacations Of Public Service Easements Pursuant To The California Streets And Highway Code, Section 8335 (a)(2). ((Majority Vote Required)

**Whereas,** Sonoma County Water Agency (Sonoma Water) owns and operates the Sanitation Zones (Airport-Larkfield Wikiup, Geyserville, Penngrove and Sea Ranch Sanitation Zones), and accepts easements for the benefit of the Sanitation Zones; and

**Whereas,** Sonoma Water manages and operates the Sanitation Districts under agreement between Sonoma Water and the Districts; and

Whereas, Public Streets, Highways, and Service Easements Vacation Law (California Streets and Highway Code, Chapter 4. Summary Vacation Sections 8330-8336) provides that: The legislative body of a local agency, or any public officer or qualified employee authorized by the legislative body may summarily vacate a public service easement by Summary Vacation when certain conditions are met and by adopting a resolution of vacation; and

**Whereas,** for a Summary Vacation, Sonoma Water staff currently prepares a Board item for approval and a resolution of vacation for adoption by the respective Board, then the Clerk of the Board or Sonoma Water records the resolution of vacation at the Clerk-Recorder's Office authorizing the Summary Vacation of the easement(s) and upon such recordation the vacation is complete; and

**Whereas,** the associated administrative costs for preparation of a Summary Vacation for Board approval and adoption of the resolution of vacation is approximately \$10,000 to \$15,000; and

Whereas, in some instances the cost can be offset by collecting an administrative fee from a requesting property owner, however there are times when Sonoma Water or Districts wish to vacate an easement no longer necessary for its use and purposes to eliminate the burden of maintenance and liability associated with retaining the easement; and

**Whereas,** Sonoma Water and Districts wish to increase flexibility and efficiency by reducing administrative costs and the time associated with preparing and presenting a Board item and a resolution of vacation for approval and adoption by the respective Board; and

**Whereas,** Section 8335 (a)(2) of California Streets and Highways Code provides that: The legislative body may delegate the authority to vacate a public service easement to any public officer or employee otherwise qualified to prepare easements or approve parcel maps or final maps as defined in Title 7 of Division 2 of the Government Code, pursuant to the authority provided in this chapter by recordation of a document containing the information in subdivision (b);

The resolution of vacation shall state all of the following pertaining to public service easements:

(1) That the vacation is made under this chapter.

(2) The name or other designation of the public service easement and a precise description of the portion vacated. The description of the portion vacated may be by a precise map which is recorded or to which reference is made in the resolution and which is permanently maintained by the public entity.

(3) The facts under which the summary vacation is made. The resolution is prima facie evidence of the facts stated.

(4) That from and after the date the resolution is recorded the public service easement vacated no longer constitutes a public service easement.

(5) Certification that all entities having any right, title, or interest in the public service easement being vacated have been notified of this action; and

**Whereas,** Sonoma Water requests the Boards of Directors (Boards) delegate authority to the General Manager of Sonoma Water, or a qualified designated employee representative, to implement the procedures for Summary Vacations pursuant to the Streets and Highway Code Section 8335 (a)(2); and

**Whereas,** Sonoma Water has prepared a template form of an administrative resolution of vacation, attached to this Resolution as Exhibit A, as an example of how Summary Vacations would be prepared by Sonoma Water; and

Whereas, Sonoma Water requests the Boards delegate authority to Sonoma Water to record an administrative resolution of vacation in the form provided as Exhibit A, or in a similar form as approved by County Counsel, at the Clerk-Recorder's Office and upon such recordation the vacation is complete; and

**Whereas,** Sonoma Water requests the Boards delegate authority to Sonoma Water to make modifications to the administrative resolution of vacation form from time to time, in a form approved by County Counsel, to remain compliant with the Streets and Highways Code or to meet other needs consistent with the findings and intent of this Resolution; and

**Whereas,** pursuant to Section 65402 of California Government Code, a proposed easement vacation must be submitted to the planning agency within whose jurisdiction the proposed vacation is situated for conformity of the adopted General Plan; and

**Whereas,** vacating an easement is routinely found to be compliant with the General Plan, however, if the vacation is determined not to conform to the General Plan by the local planning agency, Sonoma Water would prepare a Board item and resolution of vacation with appropriate findings to present to the respective Board for approval; and

**Whereas,** the Boards have previously delegated authority for discretionary projects to Sonoma Water's General Manager for the implementation and compliance under the California Environmental Quality Act (CEQA); and

**Whereas,** Sonoma Water staff have the scientific and technical expertise to determine how best to comply with CEQA; and

**Whereas,** if a proposed summary vacation of an easement does not meet the requirements for an exemption under CEQA pursuant to Section 15061(b)(3), the abbreviated procedure described above would not be implemented by Sonoma Water, and the Summary Vacation of the easement would come to the respective Board for approval.

## Now, Therefore, Be It Resolved

- 1. All of the recitals above are true and correct.
- 2. The General Manager of Sonoma Water, or qualified designated employee representative, is authorized to implement the procedures for Summary Vacations pursuant to Public Streets, Highways, and Service Easements Vacation Law (California Streets and Highway Code, Chapter 4. Summary Vacation Sections 8330-8336) by an administrative resolution of vacation attached hereto as Exhibit A, or in a similar form as approved by County Counsel.

- 3. The General Manager of Sonoma Water, or qualified designated employee representative, is authorized to make modifications to the administrative resolution of vacation form from time to time, in a form approved by County Counsel, to remain compliant with the Streets and Highways Code or to meet other needs consistent with the findings and intent of this Resolution.
- 4. The General Manager of Sonoma Water, or qualified designated employee representative, may summarily vacate any public service easement by administrative resolution of vacation. The administrative resolution of vacation shall state all of the following:

(a) That the vacation is made under this chapter.

(b) The name or other designation of the public service easement and a precise description of the portion vacated. The description of the portion vacated may be by a precise map which is recorded or to which reference is made in the resolution and which is permanently maintained by the public entity.

(c) The facts under which the summary vacation is made. The resolution is prima facie evidence of the facts stated.

(d) That from and after the date the resolution is recorded the public service easement vacated no longer constitutes a public service easement.

(e) Certification that all entities having any right, title, or interest in the public service easement being vacated have been notified of this action.

## Be It Further Resolved

The Boards hereby authorize and direct Sonoma Water to record the administrative resolution of vacation at the Clerk-Recorder's Office, and upon such recordation the vacation is complete.
