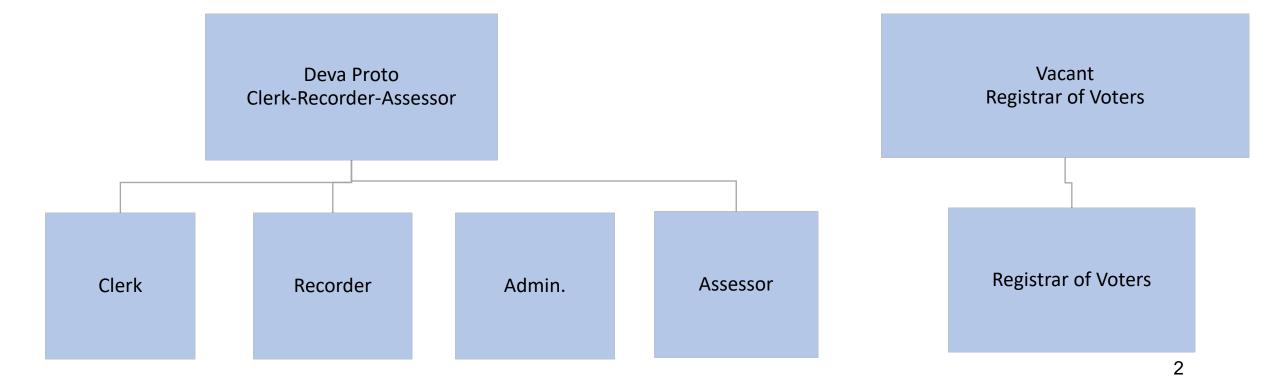

Key Operational Objectives

Assessor

- Continue progress to address assessment backlog.
- Migrate workflow processes to vendor supported packages already established by vendor to eliminate or lessen reliance on in-house applications.

Clerk-Recorder

 Perform quality control on Imported pre-1963 recorded document images into the current recording system and identify where re-imaging may be needed.

Registrar of Voters

 Successfully complete June 2026 Gubernatorial Primary election and all other elections called during FY 2025-26.

Program Change Requests

- Recorder
 - Add 1.0 full time equivalent (FTE) three (3) year time limited Senior Clerk-Recorder-Assessor position
 - Funded with <u>special revenue</u> of \$465,983 over 3 years (7/1/2025-6/30/2028)
- Assessor
 - Request extension of 1.0 full time equivalent (FTE) time limited Assessment Specialist
 - Extend the time limited position ending 6/30/2025 to 6/30/2027.
 - Funded with General Fund request of \$314,746 over 2 years (7/1/2025-6/30/2027)
- Registrar of Voters
 - Requesting to convert 1.0 FTE Account Clerk II to a Senior Account Clerk
 - Ongoing annual General Fund request of \$11,710
