


Fall 2024 First 5 Sonoma County Commissioner Recruitment: TK-12 Public Education or Early Learning & Care



First 5 Sonoma County is recruiting for a vacancy on the 9-member First 5 Board of Commissioners, to be filled by a local representative of either TK-12 public education systems or systems of early learning & care (Resource & Referral agencies, Child Care Planning).

Candidates should have deep knowledge of the current needs, interests and concerns of Sonoma County's TK-12 public education systems and how they support the needs of young children OR serve in a leadership role in either a Child Care Resource & Referral Agency or the Child Care Planning Council.

This recruitment also prioritizes the Commission's goal of increasing representation of Black, Indigenous and other People of Color in the governance of First 5 Sonoma County as members of the Commission. First 5 invests in Sonoma County's youngest children by supporting programs, systems change and public policy that promotes optimal development from the prenatal stage through age five. Investments are made through a racial-equity lens and a targeted universalism approach: ensuring that the needs of those children and families farthest from opportunity are centered and that their voices and engaged and elevated in all of First 5 Sonoma's planning processes. A strategic plan provides guidance and is updated regularly to respond to trends impacting children and families; the latest update to our current plan can be found here.



First 5 Commission Membership

Three permanent ex officio members:

- A member of the Board of Supervisors
- Director of the Sonoma County Human Services Department, or their designee
- Director of the Department of Health Services, or their designee

Six at-large members, each member representing at least one of the following:

- · Organization focused on parenting, and/or early childhood development
- · Private sector, businesses, business associations, chambers of commerce
- Child Care Planning Council or Resource & Referral Agency
- Post-secondary educator specializing in early childhood development
- Local TK-12 public education systems
- Local medical, pediatric, or obstetric associations
- Tribal organizations and communities
- City or town that has established policy and/or dedicated resources to promoting the healthy development of children
- Parent of a child who is a recipient of First 5-funded services

First 5 Commissioner Roles & Responsibilities

- 1. Actively participate in strategic policy and funding decision-making processes that centers racial equity and addresses the needs of the most marginalized children.
- 2. Elevate critical issues impacting children's health and well-being in the community and advocate for policies and resources that promote optimal development.
- 3. Attend <u>10 monthly Commission meetings annually</u> and actively participate as a member of 2 ad hoc or regular sub-committees.
- 4. Ensure fiscal accountability and ethical, responsible stewardship of public funds.
- 5. Uphold principles of fairness and transparency in government
- 6. Actively avoid all real or perceived conflicts of interest.
- 7. Complete Statement of Economic Interest (Form 700) and ethics training annually

Reimbursement of Expenses

At-large members of the Commission may request to receive reimbursement for:

- \$75 per diem for meetings and half day events
- \$125 per diem for whole day events and meetings
- Mileage
- Cost of child care necessary to attend Commission and committee meetings

The goal is to build a solid foundation for lifelong success in Sonoma County's youngest residents.

My personal aspirations in joining the First 5 Sonoma County Commission would include leveraging my extensive background in education and leadership to positively impact early childhood development.
