Resolution of the Board of Supervisors of the County of Sonoma, State of California,

Amending the Department Allocation List for the County Administrator's Office, Department
of Health Services, Regional Parks, and the Sheriff's Office, Effective July 8, 2025.

**Whereas**, during the Fiscal Year 2025-2026 budget hearing process, the Board of Supervisors supported a recommendation made by the County Executive to delete 9.25 full-time equivalent vacant allocations in the County Administrator's Office, Department of Health Services, and Regional Parks that had been vacant for at least 12 months; and

**Whereas**, on June 10, 2025, the Board of Supervisors approved the adoption of the Fiscal Year 2025-2026 budget; and

**Whereas**, Human Resources needs authority from the Board to effectuate the deletion of the 9.25 allocations in alignment with the recommendation; and

**Whereas,** on June 5, 2025, the Civil Service Commission approved a classification study conducted by Gallagher Benefit Services, Inc. to reclassify a 1.0 full-time equivalent (FTE) Administrative Aide to a 1.0 FTE Department Analyst and retain the incumbent in accordance with Civil Service Rule 3.3B; and

**Whereas,** on June 5, 2025, the Civil Service Commission approved a classification study by Human Resources to reclassify a 1.0 FTE Community Services Officer II to a 1.0 FTE Public Information Specialist and retain the incumbent in accordance with Civil Service Rule 3.3B; and
