Whereas, a proposed ordinance entitled, "An Ordinance of the Board of Supervisors, County of Sonoma, State of California, Amending Chapter 7 (Building Regulations) of the Sonoma County Code, and Adopting by Reference with Local Amendments, Selected Provisions, Chapters and Appendices of Title 24 of the California Code Of Regulations, 2025 Editions Of The California Building Standards Code, Including: (1) The California Building Code Volumes 1 and 2; (2) The California Residential Building Code; (3) The California Green Building Standards Code; (4) The California Mechanical Code; (5) The California Plumbing Code; (6) The California Electrical Code; (7) The California Energy Code, (8) The California Referenced Standards Code, and (9) The California Administrative Code; and Adopting Local Findings supporting local amendments" has been introduced and read;

Whereas, a proposed ordinance entitled, "An Ordinance of the Board of Supervisors, County of Sonoma, State of California, Amending Chapter 7 (Building Regulations), specifically section 7-12 to clarify the deciding factor on water sharing easement is the location of the well supplying the water being shared, whereas the current language focuses on the location of the parcel; amending Chapter 7A (Limited Density Owner-Built Rural Dwellings) to address a change in paragraph numbering; and
