Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, And The Board Of Commissioners Of The Sonoma County Community Development Commission Amending The Department Allocation Lists For The Department Of Health Services, The Human Services Department, And The Community Development Commission, Effective May 9, 2023, To Convert 9.00 Full-Time Equivalent Time-Limited Position Allocations To Ongoing, Extend 1.00 Full-Time Equivalent Time-Limited Position Allocation Through June 30, 2025, And Add 1.00 Full-Time Equivalent Position Allocation, As Detailed Below

Whereas, the County's Interdepartmental Multi-Disciplinary Team works to address the needs of the County's homeless and high-needs populations by providing a broad range of services; and

Whereas, the Department of Health Services, the Human Services Department, and the Community Development Commission have identified a need to convert 9.00 full-time equivalent time-limited staff position allocations to permanent, extend 1.00 full-time equivalent time-limited position allocation through June 30, 2025, and add 1.00 full-time equivalent position allocation to continue addressing the needs of the County's homeless and high-needs populations.
