**Resolution Of The Board Of Supervisors Of The County Of Sonoma, State of California
Ratifying Authorization of the Director of Permit Sonoma to Apply and Execute Grant
Agreements for the California Department of Fish and Wildlife Local Government Oil Spill
Contingency Plan Coordination Grant**

Whereas, the California Department of Fish and Wildlife (CDFW) has made available a Local Government Oil Spill Contingency Plan grant in the amount of \$10,000 for area planning for oil spill response; and

Whereas, the County participated in the Local Government Oil Spill Contingency Plan Grant Program initially under the former Fire and Emergency Services Department; and

Whereas, on September 23, 2008, the Board of Supervisors adopted Resolution 08-0805 to ratify authorization of application and execution of the California Department of Fish and Game Area Planning Grant agreement by the Director of the Department of Emergency Services for FY 2008-09 and subsequent years; and

Whereas, the California Department of Fish and Game officially changed its name to the California Department of Fish and Wildlife (CDFW) on January 1, 2013; and

Whereas, in January 2019 the County's Fire Prevention and Hazardous Materials Division was moved from the Department of Fire and Emergency Services to Permit Sonoma; and

Whereas, the grant will be utilized for the reimbursement of costs incurred by the Fire

Prevention and Hazardous Materials Division for participation in monthly area planning for oil spill response training meetings; and

Whereas, the Fire Prevention and Hazardous Materials Division can meet the criteria required for applying for the grant; and

Whereas, this grant would contribute to the County's success in participation in the Unified Command System in the event of an actual offshore oil spill,

Now, Therefore, Be It Resolved that the Board of Supervisors ratifies the prior authorization to reflect the official names of the California Department of Fish and Wildlife and the Fire Prevention and Hazardous Materials Division, thereby authorizing the Fire Prevention and Hazardous Materials Division to submit an application every fiscal year to the CDFW for a Local Government Oil Spill Contingency Plan Coordination Grant for Oil Spill Response and carry out this project, enter into funding agreements with the CDFW, and accept and expend funds for this project in the amount of \$10,000 per year or as may be increased from time to time to cover the department's participation in the program; and **Be It Further Resolved** that the Board of Supervisors ratifies authorization of application to and execution of the grant agreement by the Director of Permit Sonoma retroactive for Fiscal Years 2019-20 through 2024-25, and authorizing continued participation for FY 2025-26 and future years.
