Concurrent Resolution of the Board of Supervisors of the County of Sonoma, State of California and the Board of Commissioners of the Community Development Commission, Amending the Department Allocation Lists for the Auditor-Controller-Treasurer-Tax Collector's Office 1.0 Full-Time Equivalent (FTE), Community Development Commission (4.5 FTE), Department of Emergency Management (1.0 FTE), Department of Health Services (1.0 FTE), Human Services Department (2.0 FTE), and Permit Sonoma (2.0 FTE) to Extend the End Dates of Time-Limited Positions Set to Expire Between June 9, 2025, and June 30, 2025, to September 29, 2025.

Whereas, position extensions are needed for 11.5 FTE allocations in six (6) departments from June 9, 2025, to September 29, 2025, to prevent the initiation of unnecessary layoff proceedings, as these positions are anticipated to be further extended during or before FY 2025-26 Budget Hearings scheduled for June 2025.
