#### Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,

## Adopting New Fees And Adjusting Fees Effective July 8, 2025 For To Recover The Reasonable

## Cost Of Providing Driving Under The Influences Program Services

**Whereas,** Division 4, Title 9 of the California Code of Regulations, Chapter 3 (Title 9), provides for alcohol and drug programs, Driving Under the Influence (DUI) Program, including establishment of required maximum rates and program fees;

Whereas, the proposed rates and fees are set at amounts that will enable programs to provide adequately for the immediate and long term continuation of services as required by the state, and will continue to offset the actual cost of services;

**Whereas,** Title 9 authorizes the Board of Supervisors by resolution to establish fees to recover the reasonable cost of providing DUI Program services; and

**Whereas,** the Board of Supervisors desires to adopt and confirm the rates, fees, and schedules for alcohol and drug services provided by the Department of Health Services.

**Now, Therefore, Be It Resolved** that to recover the reasonable cost of providing DUI Program services, it is necessary to increase and amend the fees as set forth below.

**Be It Further Resolved,** based on information presented to this Board, this Board finds that the proposed fees comply with all legal requirements, including Art. XIII C of the California Constitution.

**Be It Further Resolved**, that to recover the reasonable cost of providing DUI Program services, this Board of Supervisors of the County of Sonoma does hereby adopt the following rates, maximum fees, and corresponding schedules for alcohol and drug services provided by the Department of Health Services, effective July 8, 2025, as follows: Resolution #25-Date: July 8, 2025 Page 2
