Woodard & Curran, Inc. was selected for the subject work because they have a great deal of wastewater collection system knowledge and sewer modeling experience. In addition, Woodard & Curran, Inc. is in the process of preparing the City of Petaluma's sewer collection system master plan. Since the Penngrove Sanitation Zone discharges into the City of Petaluma's sewer system, having the same consultant prepare both plans seems the best way to proceed.

Sonoma County Water Agency and its affiliated sanitation districts (collectively "Sonoma Water") are responsible for a wide variety of services that include providing potable water for approximately 600,000 people in Sonoma and Marin counties, managing eight Sanitation Districts and Zones within Sonoma County, managing flood control projects, and maintaining flood control works such as channels and drainage systems within Sonoma County. From time to time Sonoma Water requires the assistance of civil, mechanical, and/or structural engineers to provide design, analysis, inspection, modeling, and other engineering services.

On May 17, 2019, Sonoma Water issued a Request for Statements of Qualifications (RFQ) to 36 firms listed on the attached recipient list. The RFQ was also posted on the Sonoma County Water Agency and County of Sonoma Purchasing Department websites.
