

Attachment 1: Summary of Individuals Served

The American Rescue Plan Act Community Resilience Program (ARPA CRP) continues to be a positive demonstration for how the County can better collect equity-centered data to transparently share information about County investments. This expanded use case deepens the approach to collecting demographic data using the Upstream Investments Shared Outcomes System (SOMS) and tells a broader story about the impact of the ARPA CRP. Data collection in the SOMS began January 1, 2023. Prior to January, the SOMS system was not completed for the ARPA-CRP expansion and only the federal ARPA requirements were being collected. Now that the system is launched and expanded demographic data collection has begun, we can share key highlights from January 1 - June 30, 2023.

Multiple types of data are being collected in the system. Programs that are offering ongoing services to an individual are collecting a complete intake and a Social Determinants of Health (SDOH) survey for each participant. The SDOH survey is used to better understand the broad needs of a program participant and to confirm eligibility for ARPA funding. The survey is based on the validated Protocol for Responding to & Assessing Patients' Assets, Risks & Experiences (PRAPARE) tool used by Federally Qualified Health Centers. The alignment of the questions with the PRAPARE tool can allow participant's needs to be looked at broadly across the community.

The intake for programs offering ongoing services include personal identifiable information (PII), which allows us to follow a person across programs to assess broader impact. Programs offering one-time services or group activities are collecting non-PII. Both datasets include demographic data collection, but because non-PII doesn't attach the service provided to an individual, it can't be compared across priority areas. Programs collecting PII served approximately 1,322 individuals across the 9 priority areas within quarters three and four. Programs collecting non-PII provided approximately 6,107 services within quarters three and four.

In addition, based on the data collected, the majority of ARPA CRP are from the zip codes that make up the four neighborhoods under a 4.0 Human Development Index (HDI) score for Sonoma County according to the Portrait of Sonoma, which measures a person's well-being as assessed through health, education, and income. These neighborhoods are Roseland, Comstock, Bicentennial Park, and sections of Rohnert Park. Lastly, 1,021 PII participants received 1 service, 301 PII participants received 2 or more services. Staff will now be able to compare outcomes between participants who received one service compared to participants who received multiple.
