

**MODIFICATION NUMBER ONE OF

On (Date), the County of Sonoma, a political subdivision of the State of California, (hereinafter "County") and HomeFirst Services of Santa Clara County (hereinafter "Contractor") entered into a services agreement (hereinafter "Agreement").

Pursuant to Section 13.7 (Merger) of the Agreement, the parties hereby evidence their intent and desire to modify the Agreement as follows:

1. Exhibit A.3's (Program Requirements) first paragraph only is hereby revised as displayed in the appended Exhibit A.3. All content after the first paragraph of Exhibit A.3 (Program Requirements) remains unchanged.
2. Exhibit B.2 (Budget) is hereby deleted and replaced in its entirety with the attached Exhibit B (Budget).
- ?. Section 2.2 (Maximum Payment Obligation) is hereby revised to read as follows:

2.2. Maximum Payment Obligation

In no event shall County be obligated to pay Contractor more than the total sum of \$799,023 under the terms and conditions of this Agreement.

Except as expressly modified herein, all terms and conditions of Agreement shall remain in full force and effect.
