Whereas, Community Health Workers, Promotores de Salud, and Community Health Representatives play invaluable roles in our public health care system by building bridges between health and human services and community members, especially those from historically underserved and under resourced communities, utilizing vital and important cultural and linguistic skills in order to better serve their communities in effective and culturally responsive ways; and,

Whereas, Community Health Workers, Promotores de Salud, and Community Health Representative are a unique workforce whose work in their communities is driven by their love, compassion, hope, and a desire for change; and

Whereas, Community Health Workers, Promotores de Salud, and Community Health Representatives draw upon their lived experiences, cultural humility, and deep community ties to establish and maintain trust, provide culturally responsive care, and address the root causes of health inequities; and

Whereas, Community Health Workers is an umbrella term that refers to workers who may be employed under a variety of titles, including but not limited to: Community Health Worker, Community Health Educator, Patient Navigator, Peer Mentor/Counselor, Health Advisor, Lay Health Advocate, Outreach Worker and many others; and work across a variety of sectors including within the community, non-profits, schools, hospitals, clinics, and government; and

Whereas, Community Health Workers, Promotores de Salud, and Community Health Representatives are trusted members of their community and understand the complexities and

nuances within their communities which equips them with a level of community expertise that proves them to be an invaluable asset; build individual and community capacity; and increase health knowledge and self-sufficiency through outreach, community education, informal counseling, social support, and advocacy; and,
