Dear Board of Supervisors,

I am a resident, homeowner, and taxpayer in unincorporated Sonoma County, and I'm writing to express my concerns around the lack of noise ordinance in the county.

Not having nuisance noise ordinances means county sheriffs cannot do anything to address noisy neighbors.

I experienced this first hand last week when I called the sheriff's office to address a noisy house party that was happening two houses away on Lynch Rd. Even though it was midnight on a weeknight, the sheriff's office said they could not do anything because no noise ordinance exists.

This is highly unusual for a functioning county and needs to change immediately. Nuisance noise affects the health, wellbeing, and productivity of taxpayers in this county. Not being able to get a good nights' sleep affects my ability to work the next day, and contribute to my family and community. Not having a noise ordinance severely hamstrings the sheriff's office ability to do their job and serve the community.

I urge the Board of Supervisors to use today's General Plan Update process to implement reasonable nuisance noise ordinances in accordance with other noise ordinances in surrounding cities, for the unincorporated areas of Sonoma County.

Please let me know what the outcome is in regards to this issue.
